Fitzgibbon comfortably re-elected in seat of Hunter



JOEL FITZGIBBON MP Member for Hunter

ALP candidate & setting member Joel Fitzgibbon MP has been comfortably elected in the new re-distributed seat of Hunter.

Eight candidates stood with Fitzgibbon receiving just over 52% of the primary vote. Ruth Rogers for the Nats received 26.2% first preference votes with the informal vote taking 3rd place. The 'two party preferred' gave Fitzgibbon 55.68% & Rogers

The Greens ran fourth on primary votes taking just 6.8% with the best performing Independent being John Harvey from Cessnock with just under 5%. Fitzgibbon will no doubt regain a seat on the front bench with a real preference for the agriculture portfolio.

"I'd love to see Barnaby Joyce retain agriculture so he can try

& clean up the mess he has

already created," said Fitzgibbon. Fitzgibbon said he was very grateful for the electorates ongoing support.

"It remains a great privilege to represent this electorate & I commit to working as hard as I have for the last 20 years," said Fitzgibbon.

The 54 year old son of former member Eric Fitzgibbon, Joel continues a long Labor tradition in the Hunter of sons inheriting their father's seat. A former small business operator, he worked on his father's electoral staff before being elected in 1996. He also served on Cessnock City Council 1987-95, including a term as Deputy Mayor.







Raising the BARR INCONVENIENT BUDGET TRUTHS

You have all undoubtedly heard and read my ongoing concerns about the NSW Budget, the debt that we are ticking up and the disappearing sources of income. My observations on this front are not political spin; in fact quite the opposite, I am trying to un-spin the spin. Now, people will no doubt jump to the "you're Labor and you are just bashing the Government" view. I respect that this is easy to do. But, as in the past when people have accused me of this, I am more than happy to point people to the exact pages, tables, graphs and line items in the Budget that say exactly what I am saying. In addition to this, Ian Kirkwood of the Newcastle Herald wrote an excellent piece along very similar lines, on Saturday 25th June, 2016. When you un -spin the spin, there are definitely some inconvenient truths.

Question: How much debt is NSW really in? Well, what do you call "debt" and how do you measure "debt"? For those of us that manage a household budget, this is generally pretty straight forward, but not always. Let me give you this analogy: What would you say about your debt position if you had \$100,000 to pay on your mortgage, and at the same time had set aside a cash bank account that had \$90,000 in it. In the one account you were negative \$100K and in the other bank account you were plus \$90K. How much debt do you have? Some would say \$100,000 because that is what you have borrowed for the mortgage. Others would say \$10,000 because that is the gap between what you borrowed and what you have in savings. Now, that was the easy part. What if the \$90,000 that you had saved was set aside for a few projects around home that you had already negotiated and just had to hand over the money: \$50,000 for a new pool; \$30,000 for a new car and \$10,000 for an overseas holiday. If I asked the same question, how much debt do you have, what would your answer be now? For those that still answer \$10,000, although you are technically correct today, you also know that you are going to be incorrect tomorrow (or when the bills are paid) so you are actually living on a false, some would say dishonest, economy. After the new pool, the new car and the holiday, you come back to work and you have just one account left - the \$100,000 debt account. So, what if the State had \$31.664B (that's 31-thousand-six hundred and

sixty four million dollars) worth of borrowings today and, in other places, other accounts, the State had \$31.001B worth of savings, deposits and cash advances? What would you say is the size of our State debt? Is it the \$31.664B that is borrowed or is it the much smaller "gap" figure of \$663M. And having answered that question,

like we did with the pool, car and holiday above, what if the Government had already committed all of the savings to build roads and tunnels and train lines and other things in Sydney worth more than the \$31.001B available? Then, what would you say our debt position was? The Treasurer tells us that we have a "net debt" of \$663M. She is being, selectively, technically correct and mis-leading at the same time. Our Treasurer is a smart cookie – she knows exactly the web of deceit that she weaves.

The fact is that we have borrowings of more than \$31B that will need to be paid back. None of the current \$31B in 'savings" is being used to pay off any of the debt because this money is being used to pay for other things. And by the way, the \$31B in savings is largely made up of everything that has been sold across the State; things like ports, electricity assets, buildings and other profitable Government businesses. It's a bit like selling your furniture and the kitchen sink to pay for the new car. If you want to fact-check these figures you should check 2016/17 Budget Paper 1, pages C-1 through to C-6.

BEWARE OF SCAMS Especially now that we are at the end of the financial year, beware of scammers phoning to let you 'know you have a tax refund' or 'you owe the ATO money'. These people claim they are from the Tax Office and spin a great yarn – they are very convincing. They might even give you a phone number to ring them back on. DON'T! These operators are from overseas which is why it is proving nearly impossible to shut them down. Remember – the Australian Taxation Office DO NOT phone people unsolicited. They do not ask to confirm information over the phone and they do not tell you over the phone where to deposit money. If you get any phone call from someone saying they are the ATO – hang up. If you are unsure if the call was legit, ring the ATO on 132861 to verify. My guess will be that they have never made

John Martin, Mayor Singleton Council

I was delighted to attend the official opening of the \$2.93 million Ryan Avenue project. The project was funded by the NSW Government's Resources for Regions program and was officially opened by Upper Hunter MP Michael Johnsen. Ryan Avenue provides a necessary bypass for heavy traffic away from John Street and has important benefits to the community in terms of travel times, pedestrian and road safety. The project opened to two-way traffic five weeks ahead of schedule and compliments the new town centre with our unique red street lights and a

similar landscaping palette to that of John Street. Council was fortunate to obtain grant money for this project from the NSW Resources for Regions fund. Singleton Council will receive additional funding for three major bridge upgrades thanks to the NSW Governments Round Two of Fixing Country Roads. Singleton projects that have been approved for funding include: the replacement of the Brookers Creek Bridge on Mirannie Road; the upgrade of the unnamed bridge on Gresford Road and the upgrade of the bridge on Cranky Corner Road. This is an outstanding result for our community. Works on the unnamed bridge on Gresford Road are already set to commence on Wednesday 13 July and are expected to be completed by mid-September, weather permitting. I would like to thank the NSW Government for their support on these projects, without which they may not have been possible. Works on Burdekin Park are coming

along very well. The second stage of work has now been completed, with 16 trees removed and 14 trees pruned to remove dead and dying branches. I am pleased to say that our parks team has mowed, cleaned and re-opened the park. The museum and toilet blocks have also been re-opened and the bus stop has been re-located back to its original area. The next stage of works will commence from 4 July and will be carried out during the day with an ecologist and carer on standby, in an effort to minimise any disturbance to the flying foxes. The works have been approved through the 5 year licence that was granted to Singleton Council from Office of Environment and Heritage in May 2016.



Incontinence

Incontinence describes any accidental or involuntary loss of urine from the bladder (urinary incontinence) or bowel motion, faeces or wind from the bowel (faecal or bowel incontinence). It may cause distress as well as being a hygiene problem. However, incontinence can be managed and treated. If you have experienced this problem, you aren't alone. Incontinence is a widespread condition. It can range from 'just a small leak' to complete loss of bladder or bowel control. In fact, over 4.8 million Australians have bladder or bowel control problems for a variety of reasons.

It is likely that the true number of people affected is much higher. Many people do not tell their doctor or pharmacist about their incontinence, due to embarrassment. Some people mistakenly think that incontinence is a normal part of ageing or that it cannot be treated. If you experience bladder or bowel control problems seek help, as the symptoms will not go away on their own and may worsen over time. Urinary incontinence is common and often associated with preg-





incontinence. People with poor bowel control or faecal incontinence have difficulty controlling their bowels. This may mean you pass faeces or stools at the wrong time or in the wrong place. You may also find you pass wind when you don't mean to or experience staining of your underwear. About 1-in -20 people experience poor bowel control. It is more common as you get older, but a lot of young people also have poor bowel control. Many people with poor bowel control also have poor bladder control (wetting themselves). Treatment depends on the type of incontinence. However, there are lots of things you can do. Lifestyle changes may significantly

Reduce the number of drinks containing caffeine (e.g. tea, coffee, hot chocolate and cola) as they can worsen urge incontinence. Avoid constipation by maintaining a healthy balanced diet that contains plenty of fruit, vegetables and fibre. Lose some weight as a modest amount of weight loss can improve urinary incontinence.

- Aim for 30 minutes of exercise most days.
- Do pelvic floor exercises to improve stress incontinence to strengthen the pelvic floor muscle.
- Go to the toilet only when you need to. rather than 'just in case'
- Go to the doctor if you think you have a urinary tract infection.

Your local pharmacy can help too. Pharmacists can give you practical advice on how to manage incontinence as well as supply incontinence pants, pads and other aids. Visit your local pharmacy during World Incontinence Week and find out how they can help.

Easy steps for residents to reduce woodsmoke pollution this winter

Local residents are being asked to help improve winter air quality by checking they are using wood heaters correctly. As temperatures drop and winter sets in, the incorrect use of wood fire heaters can seriously affect local air quality & smoky chimneys could be a real problem in the local areas during the winter months.

"Unfortunately wood smoke pollution can harm the environment and your health and can be upsetting for neighbours," said a council spokesperson.

"We're encouraging all residents with wood heaters to go outside and check their chimneys. Ideally, chimneys should not vent any smoke, just a heat haze. Older models may vent a thin wispy smoke.

"However if your chimney has obvious smoke this means it's not operating as efficiently as it could be, regardless of its

The following ten tips will ensure your chimney produces less smoke and will help you and your neighbours breathe easy.

1. Always burn small logs of aged, dry hardwood; 2. Store wood under

cover in a dry ventilated area; freshly cut wood needs to be stored for 8-12 months;

3. Never burn rubbish, driftwood or treated or painted wood, which can pollute the air and can be poisonous;

4. Use plenty of dry kindling to establish a good fire quickly; 5. Stack wood loosely in your firebox so air can circulate;

6. Keep the flame

every year to prevent creosote build-up. Creosote is a sticky black residue that can build up in your chimney - A creosoteclogged chimney can spill smoke into your room when you open the heater, and even catch fire, putting your home at risk. Council staff members are available to give advice on using your wood heater more efficiently.

"Residents are encouraged to phone council and ask to speak to one of the wood smoke reduction officers; they will help you get the most out of your wood heater without harming your neighbour's health," he said. All local Councils are working closely with the NSW Environment Protection Authority to reduce the pollution caused

by wood smoke in our region.

Major changes to strata laws

November 2016. They have been modernised to fit the reality of living in a strata townhouse or apartment today.

The new building defect bond scheme will start on 1 July 2017. Currently more than a quarter of NSW's population lives in, owns or manages strata.

Many new requirements will not impact strata communities immediately. This includes allowing time for pre-appointed strata managing agents, building managers and executive committee members to continue in their roles once the law reforms start. Some key changes include:

- strengthening the accountability of strata
- allowing owners to adopt modern technology to conduct meetings, vote, communicate and administer their scheme the need for owners to review bylaws (strata community rules) within 12 months, which can be customised to suit their lifestyle such as whether to allow owners to keep a pet by giving notice to the owners corporation
- a process for the collective sale and renewal of a strata scheme
- a simpler, clearer process for dealing with disputes
- broadening tenant
- a new option to manage unauthorised parking through a commercial arrangement between a local council and a strata scheme
 - a clearer and simpler

which waives approval for cosmetic renovations within the strata lot (for example, installing handrails for safety).

There are also measures to reduce red tape, such as simplifying financial statements for owners. Complying with the new laws Strata schemes will have plenty of

time to understand and adjust to new requirements after the reforms start. Be aware that:

decisions already made and financial contributions already levied under pre 30 November laws remain valid once new laws

corporation continues to operate The previous executive committee becomes the new 'strata committee'. There is no need to appoint people to the strata committee until the next AGM.

Modern and flexible strata schemes

The reforms will allow a strata scheme to adopt social media, video and teleconference to hold meetings. Voting will be able to occur electronically and through secret ballots. It will also be possible to distribute papers by email.

The new laws will also give owners corporations more flexibility around when to hold their AGM. Stronger accountability for strata

managers and caretakers Strata managing agents will have new requirements to disclose conflicts of interest, including financial interests. Strata managing agent agreements will be time limited to 1 year (in the first year of the strata scheme) and 3 years in following years, with possible 3-month extensions able to be

If a strata managing agent or building manager/caretaker is not performing, owners will be able to apply to the Tribunal to vary or terminate the contract, or to be compensated.

Collective sale and renewal

This new process will allow owners to jointly end or wind up a strata scheme so the site can be sold or renewed. The reforms will ensure that owners

receive at least the market value of their lot, plus an extra amount for costs like those associated with moving.

Similar collective sale and renewal models already operate in New Zealand, the majority of states of North America, and the United Kingdom.

Maintaining the building's condition

The new building defect bond scheme will start on 1 July 2017. This start date will enable:

- strata buildings to be inspected for defects against the new Australian Standard, which will be introduced as the standard for inspections of group title buildings
- the necessary time for industry and stakeholders to prepare for this important change. This reform introduces mandatory defect inspection reports and a building bond. The developer will also need to prepare a maintenance schedule, to be tabled at the first AGM of a new scheme to inform owners about their maintenance obligations. These changes will increase builder

and developer accountability, enable defects to be identified and fixed early, and prolong the life of the building.

How the process will work

The building bond will be for the construction of strata buildings over three stories high. Developers will be required to lodge a 2% bond for the final contract price of the building, as a form of security to fix any defective work.

Developers will need to pay to engage an independent building inspector to provide defect inspection reports. A first report is due between 15 and 18 months after the completion of the building. The final report must be provided between 21 months and no later than 2 years after the building work is completed.

The owners corporation must agree to the appointment. If there is no agreement or the developer ceases to trade after the building work is complete, Fair Trading will arrange for an inspector to be appointed. If the defects are not rectified, the building bond will be used to carry out the repairs. If there are no defects or they are rectified, the bond will be returned to the developer.

Owner renovations

Current laws can make it difficult for owners to carry out minor renovations to their lot. The reforms will provide clearer, common sense approvals for owner renovations. They will waive restrictions for cosmetic changes to lots such as inserting a picture

Renovations with a lasting impact, such as installing floorboards, will still require approval but only a general resolution (50% of the vote). Renovations like those that affect the structure or external appearance of the building, or waterproofing, will still require a special resolution (75% of the vote). Top of page

Proxy voting

Changes to proxy voting will prevent an individual controlling owners' decisions by obtaining a majority of proxy votes (that is, voting rights delegated to them by other owners).

Proxy votes able to be held by one person will be limited to:

one proxy vote only for schemes with less than 20 lots, or

5% for schemes with more than 20 lots.

By-laws Reforms will introduce a model bylaw dealing with smoking that intrudes into the common property or another person's lot. The reforms will also amend the model by-laws to make it easier to keep pets. Model by-laws provide a guide for schemes to use in deciding on their own enforceable by-laws

Reforms will allow schemes to take more action against the misuse of parking spaces and excess noise, as well as introduce increased fines for non-compliance.

The changes will introduce measures to help address overcrowding in strata schemes.

Tenant participation

Tenants will have a right to attend owners corporation meetings, no matter how many of the lots are tenanted in their scheme. Tenants may vote only if they hold a proxy (giving them voting rights on a lot owner's behalf). The owners corporation may vote to allow a tenant to speak on a particular matter. Tenants can be excluded from a meeting when financial matters are discussed. If at least half the lots are tenanted, a tenant representative can be nominated as a non-voting member

representative may still be excluded from meetings when financial issues are discussed, such as the collective sale or renewal process. Levies and capital works funds New laws will require developers to set realistic levies during the period between when the strata plan is registered, and the developer has sold at least one third of the unit entitlements in the scheme (the initial period) and for the subsequent year after.

will help it ensure owners corporations can run more smoothly where there is dysfunction in a scheme. These include removing members of the executive committee and the strata managing agent and forcing elections of office holders.

Currently the only option for the Tribunal is to appoint another strata managing agent to replace one who isn't performing. This may not be the best response to a number of these issues. It can be costly to a scheme and create disharmony for lot owners.

The Tribunal will also be able to limit the matters that committees can make decisions about, and require votes on certain matters.







(The first novel of Carl Hiaasen that I read & thoroughly enjoyed was 'Native Tongue'; I remember the first page & thinking ... where is this going? It got better & better.

I have read all his adult fiction & they are all great reads with just one (his first novel) 'Tourist Season' not fulfilling my expectations. Around the same time I was also introduced to a new Australian author Robert G. Barrett who went on to be Australia's best selling fictional author to the despair of the Australian literati. Ed.)

Razor Girl Andrew Yancy (Bad

Monkey, 2013) returns in this immensely entertaining wild ride through the Florida Keys. He is still doing penance as a health inspector on roach patrol for an earlier assault with a car vacuum. But when the star of a redneck reality show called Bayou Brethren goes missing, Yancy sees a chance to win back his real cop job at the sheriff's office. Merry Mansfield, the Razor Girl, is sharp, that's for sure, and one of the coolest characters Hiaasen has ever brought to the page. She runs car-crash scams but has the proverbial heart of gold, which lands her bejeweled flip-flops in a diabolically complicated

story that includes (and often skewers) phony reality shows and the fine folks who bring them to us: goofball goodfellas: sand-restoration, reefraiding scammers; an illfated, mongoose-owning stinky copycat psycho; a high-profile productliability lawyer who's dangerously addicted to the very male-enhancement potion for which he recruits litigants in his TV commercials. And, oh yes, let's not forget an environmentally invasive infestation of Gambian pouched rats, electric cars, and cruise lines, along with Sharpie pens that create a male enhancement that perhaps only this author could dream up. Or maybe it is one of the true lurid Florida tales he claims to have incorporated into the story? This is the ultimate beach read for anyone with a taste for Hiaasen's skewed view of a Florida slouching toward Armageddon .--ANOTHER LOOK..... The full-tilt, razor-sharp,

unstoppably hilarious and entertaining novel from the best-selling author When Lane Coolman's car is bashed from behind on the road to the Florida Keys, what appears to be an known as Blister who's ordinary accident is anything but (this is Hiaasen!). Behind the wheel of the other car is Merry Mansfield--the eponymous Razor Girl--and the crash scam is only the beginning of events that spiral crazily out of control while unleashing some of the wildest characters Hiaasen has ever set loose on the page. There's Trebeaux, the owner of Sedimental Journeys--a company that steals sand from one beach to restore erosion on another . . Hiaasen was born in 1953 and raised in Plantation, Florida, then a rural suburb of Fort Lauderdale. He was the first of four children born to Odel and Patricia Hiaasen. He has Norwegian and Irish ancestry. He started writing at age six when his father bought him a typewriter. After graduating from Plantation High School in 1970, he entered Emory University, where he contributed satirical humour columns to the student-run newspaper The Emory Wheel. In 1972, he transferred to the University of Florida, where he wrote for *The Independent Florida Alligator*. Hiaasen graduated in 1974 with a degree in journalism. He was a reporter at Cocoa Today (Cocoa, Florida) for two years before being hired in 1976 by the Miami Herald, where he worked for the city desk, Sunday magazine and investigative team. Since 1985 Hiaasen has been a regular columnist for the newspaper. His columns have been collected in three published volumes, Kick Ass (1999), Paradise Screwed (2001) and Dance of the Reptiles (2014), all edited by Diane Stevenson. In 2005, Hiaasen was the subject of a "60 Minutes" (USA) profile by Steve Kroft.

After becoming an investigative reporter, Hiaasen began writing novels in his spare time. His first three were co-authored with his friend and fellow journalist William Montalbano: Powder Burn (1981), Trap Line (1982), and A Death in China (1984). His first solo novel, Tourist Season (1986), featured a group of

agged eco-warriors who kidnap the Orange Bowl Queen in Miami. The book's main character was whimsically memorialized by Jimmy Buffett in a song called "The Ballad of Skip Wiley." In all, seventeen of Hiaasen's novels and nonfiction books have appeared on the New York Times Best Seller lists. His work has been translated into 34 languages.

Hiaasen's newest novel, Razor Girl, was published this yea

His first venture into writing for children was the 2002 novel Hoot, which was named a Newbery Medal honour book and was adapted as a 2006 film of the same name (starring Logan Lerman, Brie Larson and Luke Wilson). Hiaasen's subsequent children's novels were Flush; Scat: Chomp and, most recently, Skink-- No Surrender, which introduces one of his most popular adult characters to teen readers. All of his young-adult books feature environmental themes, eccentric casts and adventure-filed plots.

Hiaasen also co-wrote three songs with his good friend and famed L.A. rocker, the late Warren Zevon. "Rottweiler Blues" and "Seminole Bingo" appeared on Zevon's Mutineer album in 1995. The third song they wrote together, "Basket Case," was done in conjunction with Hiaasen's novel of the same name, and appeared in 2001 on Zevon's album My Ride's Here.

Hiaasen is also noted as the person who helped bring the young adult fantasy novel Eragon to the public. The book, written by Christopher Paolini, was self-published and self-promoted without much attention until it came to the notice of Hiaasen's wife, Fenia, in 2002, during a trip to Montana. Hiaasen immediately recommended the novel to one of his editors at the publishing house Alfred A. Knopf. The book went on to become an astounding success, marking the start of a series that sold over 30 million copies worldwide

Tourist Season (1986), Double Whammy (1987), Skin Tight (1989), Native Tongue (1991), Strip Tease (1993) (filmed in 1996 as Striptease by Andrew Bergman, starring Demi Moore and Burt Reynolds), Stormy Weather (1995), Lucky You (1997), Naked Came the Manatee (1998) (A Mystery Thriller Parody with 12 other authors), Sick Puppy (2000), Basket Case (2002), Skinny Dip (2004), Nature Girl (2006), Star Island (2010), Bad Monkey (2013) & Razor Girl (2016)

as the star of a redneck reality show called Bayou Brethren . . . a street psycho more Buck Nance than Buck could ever be . . . Brock Richardson, a Miami product-liability lawyer who's getting dangerously-and deformingly--hooked on the very E.D. product he's litigating against . . .





Will My Floppy Work With Windows 10?

One of the big changes in Windows 10 is that the OS no longer has built-in support for floppy drives. I first told you about this more than a year ago. 
Or you can try this: type "Find and Fix Problems" in your search box and click on the results. Then select Hardware & Sound.

The benefits of the Torrens Title system

One of my constant themes throughout all the series I have written has been the benefits of the Torrens Title system - a system as the then Chief Justice of Australia wrote - not of registration of title but of title by registration; that is that one does not have title till one is registered.

But there are a few exceptions to this rule that you don't have title unless its registered and the first and most important of them is easements.

The Real Property Act - the act setting up the Torrens system in New South Wales provides that a registered proprietor's interest in land is subject to the omission or misdescription of an easement subsisting immediately before the land was brought under the provisions of this Act or validly created at or after that time under this or any other Act or a Commonwealth Act.

Incidentally, the phrase the act uses to describe an owner "The registered proprietor" again shows the importance of being registered.

The first group of easements that trump a registered proprietor's interest is an easement that existed before the land burdened by the easement was brought under the Torrens title system. I've written about this before, telling you that there are several properties in High Street Maitland where there were easements created by a written agreement (generally a 'conveyance' - the deed used to transfer land that isn't under the Torrens system but sometimes a deed simply creating the easement) before the land was 'converted' to the Torrens system and do not appear on the Torrens

The reason appears to be that the Registrar General - the government office controlling the title registries - does not normally record these easements on Torrens title deeds when it converts the title which it does these days by a largely administrative process. This in turn is because it does not search back the chain of title deeds to see whether an easement was created perhaps 80 years ago but only examines the most recent deed and then issues a Torrens 'certificate of title' based on that most recent deed.

The problem can be fixed - even when the owner of the land burdened by the easement refuses to assist you. I've done it. You lodge a form - called a Request - asking the Registrar General to register the easement with two other documents. First a supporting 'search 'showing the title deed by which the easement was created and every title deed since (these are required to show that the easement was not released in the years between when it was created and when the land was brought under the Torrens system). Second a

can remember been in use. The Registrar General then writes to the owner of the land burdened by the easement telling him or her that unless he or sne takes action within a month the Registrar General will register the easement on their land. The action is normally to seek a "declaration" in the Supreme Court that the easement does not exist. I have never seen anyone take that

action. But as I wrote in my series on roads and rights of way last year easements are not always created by a written agreement. They can be created by "implication" by, for example, an owner of land building a duplex on his or her land - such that each house of the duplex requires support for the common wall from the other house (which is usually the case) and then selling one of the houses. An easement for support will arise in favour of both blocks of land. Another and more contentious issue (and I've written about this before) is when an owner uses part of his or her land to the benefit of another part of their land in such a way that had it been two separate lots an independent person would have thought there was an easement over the part used and in favour of the part benefited. The owner then sells the part so benefited. The law implies an easement. Examples of such a use are a drain on part of the land draining the other part, part of the land being used for vehicular access to the other part, and even the right to use a "garbage room" in a large shopping centre.

These implied easements also prevail against the registered proprietor. Perhaps the best example is one of the first cases to decide this, the Court of Appeal decision in Beck v Auerbach. Before 1911 two houses were built on two

adjoining blocks owned by the one owner. Perhaps because survey techniques were then not nearly as good as they are now, the wall of one of the homes was over the boundary of the adjoining block and pipes and wires overhung still further.

In 1911 the owner sold the block on which was the house which encroached onto the adjoining block which he retained. Soon after the new owner successfully applied to have his block brought under the Torrens system (in those days the only way to 'convert' the title system was by a "Primary Application" a quite involved and expensive procedure - these days there are several other simpler ways).

The original owner sold the block he retained and some time later a later purchaser of this land also successfully applied to have this block brought under the Torrens system.


Both conversions had been done without anyone apparently noticing the encroaching wall, pipes and wires.

60 years later – in the 1980s there was a dispute between the then owners (who by then were many steps removed from the original ones), and the owner of the land who encroached on the other sought and obtained orders that that they had a right to go into and upon the adjoining land to maintain and repair their own home and the right to permit such parts of their own home as overhung the adjoining land in 1911 to continue to so overhang. Both of those rights are easements and had been omitted from the title deed. The title deeds were then corrected by court order to show the easements.

The most interesting comment the judges made from my point of view is that the primary obligation of the Registrar-General is to investigate and to consider the title of applicants seeking to bring land under the Act and that investigation required consideration of the question whether any and if so what easements had been created in relation to the building on the adjoining land and which should be noted on the applicant's certificate of title.

The court continued by saying A proper investigation would have revealed the existence of the easements (for overhang, support and access to carry out repairs)

I say that is the most interesting comment because it strongly suggests that the Registrar General should investigate titles more fully when converting them to Torrens land and not rely on its present practice in just looking at the current deed. (In the next article I will deal with easements "Omitted" where the land has always been under the Torrens system). Cheers, Peter



..... enjoying the Hunter Wine lifestyle with Andrew Marsh of Marsh Estate Winery, Pokolbin



As you are reading this article Holly and I are in W.A., attending a wedding in the beautiful Margaret River area. I will then spend three days surfing the famous "North Point" at Cowaramup Bay, which on a map you will read as Gracetown. This is where that young chap was taken by a shark six or so months ago. This surf break is so good that Kelly Slater, in his recently published autobiography, Pipe Dreams, names it in his top ten surfing spots in the world. But, get this, in brackets next to it, it reads ("I've never actually surfed there, but its reputation exceeds it."). That is like Tiger Woods including The Vintage in his top ten golf courses in the world, without actually ever playing there. That's how good this place is.

My middle brother, Nick, has lived in Cowaramup Bay for thirteen of the last fifteen years. Nick's in the wine industry and has worked at many of the well-known wineries in Margaret River. Fifteen years ago there were only a handful of wineries operating so he is part of the old crew, even in that short space of time. Nick did not go to Margaret River for the wine, however. The wine industry just allowed him to follow his dream. Two words dragged Nick out of Roseworthy College in South Australia, across the Nullabor and into a relatively unknown but beautiful area known as Margaret River - "North Point". Cowaramup Bay is one of surfing's most picturesque

landmarks. Looking at the bay from the beautiful old style village of Gracetown (confusing - Gracetown is situated overlooking the bay), there are four surf breaks in view. On the southern side and just south of the headland is "Lefties". The southern point is the aptly named "South Point" which handles good swells from any direction. Coming into the bay is a smaller wave known to locals as "Hazzar's". Then, as you look to the northern end of the bay you witness a wave so powerful that it rates with some of the famous breaks of the North Shore of the island of Oahu in Hawaii. "North Point" can be your greatest highlight as a surfer or your worst bloody nightmare. Behind the breathtaking beauty of Cowaramup Bay lies a deeply horrifying past. Not only has the Bay featured in the media through shark attacks, in the early 90's a group of local school children and some of their parents were crushed to death as they sat in an open cave overlooking the Bay. Many of you will remember this. What you don't hear however, are the frightening stories of unwary surfers taking on North Point. The last time I surfed there was October 2003 and I nearly died....twice. The same day two surfers from Perth had to be resuscitated and a local friend of Nick's spent seven weeks in hospital with a total The coastline around Margaret River is of 280 stitches to his head, shoulder, hands and feet, with

several other complications. Here on the east coast of Australia you hear of massive swells hitting the coast and the stories that follow. In the west it is always massive, so days such as the one I experienced last time are numerous, just another day. To be dealt a blow at North Point is not like getting back on a horse that throws you or a bicycle mishap, it is a warning. Chasing the rush which surfing gives you is addictive, it is never ending. You often take chances you'd rather not take but something inside you pushes the boundaries. It's one thing to surf the beach breaks of Sydney. You then start taking on the point breaks which add a new dimension. As your curiosity grows you find yourself surfing rock bottom reefs of which there are many around the east coast. The lure of the Indonesian islands (where we will be heading to on Friday - but we have had to scrap Nias because of the

earthquake) you're a travelling surfer with a quest which is never ending. Once you reach the Hawaiian Islands the seriousness of your quest sets in. The waves of Sunset Beach, Waimea Bay and Pipeline are famous throughout the world. No doubt you've heard of the Banzai Pipeline, a harrowing barrel, breaking only 30 metres off the beach, over a foot or two of water with a fatal coral reef floor. One of Hawaii's favoured sons and current tour professional, Shane Dorian, describes Pipeline as "Surfing's epicentre". Shane describes North Point as "Surfing's greatest obstacle....the only time I've seen my life flash before my eyes.....totally insane!" Margaret River houses some of the most revered waves in Australia and the world. Names such as "The Womb", "The Gallows", "Guillotines", 'Supertubes", "Moses Rock",

"Barnyards" and "Cobblestones" are just a handful of the most unique breaks on the untouched coastline of Western Australia. You may never have heard of them, but they make Margaret River one of the most famous areas in the world. "North Point" stands alone in the "cursed" Cowaramup Bay and will forever be one of Australia's best kept

When I hear people talking about Margaret River, it is generally in regards to the wine of this region. Whenever people ask me about the area my mind sits in a hollow right-hand barrel, praying I'm going to come out alive. I think of snapped surfboards, open wounds and shattered dreams as surfers come face to face with the power of the Indian Ocean. Wine is my life and I have and always will, travel from one end of the earth to the other to find and experience the greatest vineyards and their subsequent wines but when you mention Margaret River, the furthest thing from my mind are the wines. Don't get me wrong, I have my favourites which I know and buy, but the natural attractions of the area far surpass any of the human interventions.

While most people organise a trip to Margaret's by booking accommodation and restaurants with a view to visiting wineries and galleries and the like, I am making sure my life insurance, private health care and a selection of surfboards are ready to go. You may think it is a shame that I feel the wine industry holds second tier in Margaret River but I believe it does. Many people visiting the Hunter, nowadays, may prepare by making sure their seven iron or three wood is in good condition but the vineyards were here first and are the reason the Hunter Valley is famous. In Margaret River, one guess as to who was there first – the vineyards or the surf? remote, rugged and volatile. Its beauty lies in its "rawness". The only thing that may, one day, destroy this is an overdeveloped tourist boom in cooperation with an already overdeveloping wine industry. The Hunter's strength and beauty lies in its vineyards; Margaret River's lies in its surf. The vineyards certainly compliment the area at this stage (especially the top Chardonnays and Cabernet based wines) but by no means are they the strength of Margaret River. On the other hand, could you imagine the Hunter without its

vineyards?? I rest my case.

Sebring 2015-16 progeny earnings exceed \$11million

SEBRING, the More Than Ready 2007-08 champion 2yo who is the fifth Golden Slipper winner to stand at the Widden Stud, a distinction he shares with Stratum, Marscay, Vain and Todman – in his twilight years, has consolidated his eminence as one of Australia's best sires of this time with progeny earnings in 2015-16 in excess of \$11million.

With a month to go, his Bloodhound statistics for the year read122 winners (110 Aust), 9 stakes winners (7 Aust), 15 stakes placed,182 wins (158 Aust) and earnings of over \$11million (\$7,700,000 Aust). He is in the top ten leading sires for Australian racing by earnings, winners and wins and also in the stats for the juveniles, contributors including

The statistics for the year take the 11-year-old Sebring's sire career record to date (oldest five) to 220 winners (21 SWs,11 Group winners), 464 wins and \$30million. Heading his honour board are Dissident, the Australian Horse of the Year, Champion Sprinter and Older Horse 2014-15, and Criterion, the Equal Leading Older Male (Extended) in the 2015 World Rankings.

Dissident, fee \$33,000, went to 2015 mares in his first season at stud last year and Criterion, fee \$35,750, can expect a big book when he debuts this year. Comprehensive details on these sires, both at the young Hunter Valley powerhouse Newgate Farm, are in the recently published 2016 National Stallions, an edition published by Bluebloods magazine (www.stallions.com.au) and also containing information on five sire sons of More Than Ready. They are Sebring (Widden, fee \$77,000), Better Than Ready (Lyndhurst, Warwick, fee \$9,900), Pluck (USA), proven sire, Vinery Stud, Scone, fee \$9,900), Ready for Victory (new at Sun Stud, Victoria; fee \$9,900), and War (Blue Gum Farm, Victoria, third season \$6,600).

More Than Ready (fee \$66,000, Vinery) also appears in Stallions himself as the broodmare sire of Unencumbered, a fleetfooted Testa Rossa 2-year-old who went to stud at Three Bridges in Victoria in 2014. He stands on \$13,200 and has had books of 119 and 125

The Queensland Stallions book for 2016 contains two sons of More Than Ready, Lyndhurst's Better Than Ready (fee \$9,900) and Mahisara, a stakes winning son of the Danehill mare Darsini retired to the Turkington's

Wattle Brae Stud in 2014. On \$6,600 for 2016, Mahisara went to 100 mares in his first season and 119 in 2015.

Bindi Cheers has Exceed and Excel sire at Taree

BINDI CHEERS, a prominent trainer at Taree on the mid north NSW coast, will be looking to have some of the Stanley Wootton magic rub off on the fashionably bred Pitleco, a sire she is standing this year on a modest fee of \$2,200.

A \$310,000 Easter yearling who did not race owing to an injury, he is a 2006 result of the mating of the Danehill champion sire Exceed and Excel with Twiglet, a Twig Moss (Fr) Group 2 winner from Extradite, a Bletchingly Sydney winner and stakes placed daughter of Expulsion (GB), a winner by Showdown's sire Infatuation. Pitleco and his dam were bred by Mrs Catherine Remond NSW and Expulsion by her father Stanley Wootton.

A three-quarter brother to Hong Kong superstar Fairy King Prawn (five Group1 wins HK and Japan) and Crevette (triple Listed winner, dam of G1 winner Cosmic Endeavour) and half-brother to Easy Rocking Fame, and grandson Tom Dabernig and (G1 winner, sire good winners Wattle Brae, Qld), Pitleco is already a proven sire from light use in WA. Oldest 3yos 2015-16 include Gold Club (winner Esperance, five places Perth), Napa Liaison (7 starts, won Esperance) and Best Day Ever (3 starts, 3rd Roebourne 1100m June 4). A white horse makes Queensland breeding history

OUEENSLAND breeding history has been made this year with the appearance for the first time in an Australian thoroughbred stallion register of a white horse. Truly named PURE WHITE, he is one of three sires based at the Kelly family's long established Royston Stud, one like Glenlogan Park and the Sun Stud, located in the Innisplain Valley, whose qualifications, pedigree and



photograph are among 49 in the Queensland Thoroughbred Breeders 2016 edition of their Stallion Register.

On a fee of \$4,400, the Australian bred Pure White starts his career at Royston this year alongside another newcomer in PRINCE CHERI (FR) (Lando (Ger) Princess Cheri (Ger), by Mondrian (Ger), a winner France (two starts), Group 3 winner, Goup1 performed Australia, fee \$6,600, and proven sire of stakes winners LONGHORN (Danehill - Fitting, by Marscay) fee \$4,400.

The appearance of Pure White at stud follows the enterprise of the founders of the Winning Colours Farm at Rockley, near Bathurst in importing coloured thoroughbreds from America. A foundation sire has been PROFILE IN STYLE, 'a world class and performance coloured thoroughbred stallion'

A bay bred in America in 2006, Profile In Style appears to the first ever frame overo thoroughbred to come to Australia. He has a fashionable thoroughbred pedigree, being by Ellusive Quest, a bay with a lot of white by a son of the influential Halo and from a mare by the Secretariat sire Shantariat.

So far Profile In Style has had 64 foals registered by the Australian Thoroughbred Stud Book. Three are white, including Pure White (2011) and a younger brother born 2013. They are from Laughyoumay, a white daughter of Sky Chase (won Champagne Stakes, Rosehill Guineas, Gloaming Stakes, Chelmsford Stakes and Caulfield Stakes) and from Harrisburg, a stakes placed daughter of Diagramatic (USA).

A stakes performer in France and America used at the Waikato Stud in New Zealand when it was owned by Texas oilman Nelson Bunker Hunt, Diagramatic was by Sir Wiggle. He was from Wiggle, an exported champion Australian 2-year-old who at this age won the Stradbroke at Eagle Farm.

Wiggle, a daughter of the Nasrullah sire Rego (Ire), was bred ten minutes drive away from the famous Kia Ora stud, Segenhoe Valley, Scone, one which bred the Hall of Fame inducted Shannon. Also exported to America, Shannon's fourth dam, Brig of Ayre, was a half-sister to Santa Cruz, a bottom line ancestress of Pure White.



Quality was mixed, with percentages of the younger cattle showing the effects of the colder conditions. Numbers lifted, with the bulk of the penning entering the younger categories, as the majority were suitable for the restockers and requiring extra finish. There were numbers of prime- conditioned vealers and yearlings suitable for the butchers in the penning, with some lots well-muscled and high yielding. The usual buyers competed in a firm to cheaper market. The vealer steers purchased by restocker



orders slipped 11c, as the medium weights made from 330c to 370c, with the heavier end topping at 369c before averaging 357c/kg. The heifer portion also to restocker orders sold 2c cheaper selling from 321c to 343c/kg. Yearling steers to the restockers sold close to firm ranging from 330c to 358c/kg. The unfinished yearling heifers also sold close to firm making from 300c to 331c/kg. The limited supply of prime-conditioned younger cattle to the butchers sold to strong competition, with well-muscled heavy vealers topping at 384c/kg. Grown steers slipped in quality, week-on-week, with the heavy weights to slaughter averaging 307c/kg. Cows slipped 15c, as the plainer 2 scores averaged 229c, with the better finished 3 and 4 score heavy weights making from 242c to 260c/kg.

Scone report date 5 July 2016

Yarding 1423 ~ **Change 798** (Comparison Date 28/6/16)

Consignments more than doubled compared to the last rain affected market, with quality fair to good. The younger categories made up the bulk of the penning, with around 140 cows also offered. There were good percentages of the younger cattle showing good finish and suitable for the butcher orders, with the best of these



grain-assisted and high yielding. The usual buyers competed in a cheaper market. The medium weight vealer steers returning to the paddock slipped 13c, making from 321c to 369c/kg. The equivalent weighted heifer portion to the same orders lost 7c to range from 305c to 358c/kg. Yearling steers sold to strong restocker and lot feeder competition, as prices sold from 305c to 364c, depending on breed. The yearling heifers sold from 315c to 349c/kg, with the lot feeders paying the premium for the better end. Heavy grown steers to slaughter sold at 310c/kg, with some carrying plenty of weight. Cows eased 3c to 6c, as the plainer 2 scores averaged 239c, with the better covered 3 and 4 scores ranging from 240c to 276c/kg. Heavy weight bulls averaged 231c/kg.

TRLX Tamworth report date 4 July 2016

Yarding 1772 ~ Change 397 (Comparison Date 27/6/16)

There was an increase in supply with yearlings and cows well supplied. Heavy grown steers were in fair numbers. The overall quality and condition of the offering was mixed with all buyers catered for. There were some high quality cattle in the feeder categories as well as in the heavy steers to process. All the usual buyers were in atten-



dance. Demand was solid throughout the young cattle with most categories showing firm to dearer market trends. Vealers to restocker were up to 20c/kg dearer for heifers, the steers showing a smaller rise. Yearling steers to restock and feed remained mostly firm, however there was some quality and breed related price change. Heifer yearlings to restock and feed sold to a dearer trend, up 2c to 6c/kg. Medium weight trade heifers were cheaper, while the heavy weights were slightly dearer. The quality of the heavy grown steers contributed to dearer prices on an improved market trend. This category also included some heavy milk tooth lines. The market trend for cows was generally firm to slightly cheaper, however there were odd sales in the 2 score medium weight dearer. Yield potential was a factor in those sales.

The Australian cattle industry will be influenced by a number of extreme forces in


From a cattle supply point of view, numbers over the coming two years will fall to levels not seen in more than twenty years. This alone will

more than likely stimulate strong competition between restockers, feedlots and processors for the limited availability.

The national herd is estimated to fall to 26.2 million head by 30 June 2016, before declining slightly again in 2017, to 25.9 million head. If this occurs, it will represent a 3.4 million head, or 12%, fall since 2013 and become the lowest national herd for 24 years (1993).

Working to partly offset the projected 16% year-on-year decline in adult cattle slaughter for 2016, at 7.6 million head, will be the expectation that average carcase weights will increase considerably. This assumption is based on much lower stocking rates, a greater proportion of lighter northern cattle exported live, a higher proportion of cattle on feed and fewer female cattle processed. Beef and veal exports are

expected to fall as a result of lower production, not due to waning demand. The prediction of the A\$ to average between 66-69US¢ is a significant positive, but needs to be balanced against the heightened competition from Brazil in many markets, the expectation of high US poultry and pork production, higher year-on-year US beef production and significantly weaker US beef markets compared to 12 months ago.

Reflection on the Gospel-16th Sunday in Ordinary Time C, 17 July 2016 (Luke 10:38-42)

This gospel story forms part of a broader Lukan canvas where women provide the model for leadership but are more often than not excluded from its exercise, writes scripture scholar Sister Veronica Lawson rsm. The story of Martha and Mary has been interpreted fairly consistently over the centuries. Mary's silent contemplative pose at the feet of Jesus is generally affirmed while Martha's action-oriented focus is seen as a less desirable Christian stance. To be a "Mary" is to "choose the better part". To be a "Martha" is to be "anxious and distracted about many things" In recent times, some interpreters have re-evaluated this reading of the Martha-Mary story. They have drawn attention to the many voices that inform the gospels and have suggested that this particular text reflects a struggle in early Church communities over the role of women in leadership and ministry. One voice in the text comes from those who want to downplay the initiative of women like Martha and to affirm the silence of women like Mary. The same voice functions to pit the two women over against each other and to cast Jesus in the role of arbiter between them, approving Mary's choice over against Martha's. This voice has had the effect of creating a false dichotomy and of reducing the women to exemplars of active ministry on the one hand and of quiet contemplation on the other. In other words, the judgment of Luke's Jesus reflects the views of a certain group in Luke's house churches rather than the words of Jesus of

A more women-friendly voice in the text presents Martha as the householder who welcomes or receives Jesus into her household church. This is possibly the voice of a circle of women disciples who preserved memories of women like Martha and Mary in less divisive ways. For these women, Martha is a generous host who uses her resources for the sake of the community. She welcomes those who share faith in Jesus, among them her sister Mary. The designation "sister" does not necessarily denote blood relationship. Mary may be one among many sisters and brothers in faith who gather to hear the teaching of Jesus. According to the narrator, Martha is "pulled in every direction" (periespato) by many ministerial tasks (peri pollen diakonian), and most leaders can sympathise with her in this. There is no indication in this description that she is distracted. This is in contrast with the subsequent evaluative comments of the Lukan Jesus: coming from the lips of Jesus, the expression "anxious and troubled by many things" services a negative interpretation of Martha's leadership. This story is problematic in many ways. It forms part of a broader Lukan canvas where women provide the model for leadership but are more often than not excluded from its exercise. This is in stark contrast with the ways that women are presented elsewhere in the gospels, especially
