Sue Moore said it was now a matter for Singleton Council to work with the State Government to ensure the design incorporated the needs of the local government area. Council wrote to the Roads and Maritime Services (RMS) in November 2015 in support of Option B, because it would best contribute to the sustainability of Singleton. Cr Moore said she learned of the preferred route at the announcement by Upper Hunter MP

Michael Johnsen on Tuesday. "Council is extremely happy that a decision has been made on the route which will allow this much-needed project to progress. The Singleton bypass is a State Government project, and will be funded by the State and Federal governments.

On page 11 you will see an article telling us that from Monday 6 March next year residents in Maitland, Cessnock and Singleton Local Government areas will be supplied with a new bin sporting a lime green lid as part of the roll out of a kerbside garden organics collection service. The roll out of the bins will start in January and will take about seven weeks. The 3 councils obtained a \$2.2million grant from the state government which allows them to provide the service at no extra cost which is good news. The 'Sulo' waste collection system has been a Godsend to garbage services not just in Australia but all over the world for its cost effectiveness & ease of collection. Interestingly one of our wheelie bins at our office is dated 1983; 33 years in use and still has some years



The accolade for the first functional wheelie bin, and the one in which most modern plastic wheelie bins are descended from, goes to the UK company, Frank Rotherham Mouldings, which invented the wheeled bin in1968. Though its use was limited to the transportation of waste across the factory floor, the wheeled bin would have

possibly gone unnoticed, until an eagle-eyed health and safety inspector realised that the bin could improve efficiencies and reduce the amount of injuries to refuse

collectors. It wasn't until the 80s where a new type of refuse collection vehicle emerged, which could automatically pick up and empty the bins, that wheelie bins were


Check & see!

Raising the BARR SPORT & RECREATION CAMPS – FOR SALE

A really crucial part of a child's school experience is the school camp. In NSW Sport & Rec camps have been a vital cog in the wheel for the past 60 years. The idea of the Government run Sport and Rec camp was to secure beautiful land and wonderful experiences for the children. That's why our S&R Camps are on lakes, rivers, waterways and even down at Jindabyne near the snowfields. For many children, many of the experiences that they have at a Sport and Rec Camp will be the first, and sometimes only, time to do many of these things. Canoeing, archery, campfire, sailing, climbing walls, team building, high ropes, open fire cooking, etc.

Rather than being run as non-profit, Government subsidised, low cost centres, as they have been for 60 years, the Government have now decided that these centres should be sold off to for-profit businesses. Of course, the obvious way to drive a profit would be to raise the cost to each child attending, reduce the staffing and staffing qualifications (rates of pay), cut back on food quality/quantity and reduce maintenance and upkeep of the facility. The other obvious future of a for-profit centre includes high cost high end new accommodation being built on these Crown Reserves so that those with the cash can have the most wonderful of experiences, while those without will be excluded from access. Locally, think to yourself of the beautiful sites at Myuna Bay and Point Wollstonecraft. Imagine how excited developers must be at the idea of owning these parcels of land on our beautiful Lake Macquarie. This is modern Bairdeconomics.

CROWN LAND – FOR SALE Because NSW was established long before the Federation of Australian states, when white Europeans first settled in Australia in 1788, the land was declared the property of the Crown and thus became the property of NSW. Don't get me started on the declaration of the land as "terra nullius" which means "nobody's land"! In any case, Crown Land became the property of the state and has long had the condition of "broader public good and use" as a defining term and condition. Two weeks ago the Government moved and passed new Legislation that will allow Crown Land to be sold off, handed over, given away, transferred, etc at the whim of the Government. No longer will "broader public good and use" be a requirement. This will be an enormous problem for local Government, showgrounds and parks and playgrounds across the State that are on Crown Land, for community halls and surf life-saving clubs, for gun clubs and Scout groups - the list goes

on and on. Another developers dream come true. * * * * * * * * * * * * *

The State Government's announcement last week about the preferred option for the New England Highway bypass was a fitting end to 2016, and reinforced that there's plenty more hard work to come in 2017.

Singleton Council nominated Option B, between Newington Lane and McDougalls Hill, as its preferred option because it offered all the benefits of a bypass while retaining connectivity between motorists and the commercial centre of our LGA.

Council is now committed to working with the State Government as detailed design work progresses to ensure the best outcomes for everyone in our community, especially those property owners on the path of the preferred route.

No doubt we can draw on the experience of the planning for the Hunter Expressway, and in particular the impact on the people of Branxton. That said, the reality is the Singleton bypass is a NSW Government project, and now the design and construction progresses is a matter for them. I would encourage anyone with questions about the project to contact RMS (Roads and Maritime Services) on 1800 991 254. As the community also questions what is being done to address road safety concerns on the section of New England Highway at Whittingham, I can assure residents Council has looked very closely at what the New England Highway Draft Corridor Strategy means for that area. A very big item on our to do list in 2017 is to continue to advocate for solutions in the short term. Council already has an established track record when it comes to working successfully with the State Government, and there were plenty examples to celebrate in 2016.

Only two weeks ago we gathered for the opening of the new visitor information bay on Hermitage Road in the first completed milestone in the \$16.7 million upgrade and cycleway for Hermitage Road, a joint project with Cessnock City Council and funded by the NSW Government. In what is a real credit to the Council staff and contractors involved, the information bay looks fantastic and I'm really excited to see how work progresses next year.

But for now, it's a great time to reflect on the year that was and celebrate our achievements, and I was privileged to be part of two very special events in Branxton this week – namely the Lions Christmas Seniors' party and the end-of -year assembly for Branxton Public School.

These occasions were a great reminder of what the festive season is really all about – taking some time out to spend with the people most important to us, and recharging the batteries. I'd suggest there's no better platform to do just that than Cook Park on Friday nights for the Summer Music Series. LawAccess NSW is a great starting point for anyone in Upper Hunter Electorate with a legal issue - the support they provide will cost you nothing and could save you a lot of time and anxiety. Law Access has launched a Communications Toolkit to help people and organisations spread the word

and organisations spread the word about its services, after Law and Justice Foundation research showed one in five people with a legal problem in NSW don't do anything about it. Many people don't take action when they have a legal issue because they don't know how to, or think it will be too stressful or expensive. Legal problems rarely resolve themselves and often get worse when ignored so it's vital the community knows about LawAccess and how to find its services.

The LawAccess phone line 1300 888 529 provides free legal information, referrals and - in some cases - legal advice on civil, criminal and family law issues.

> LawAccess began in 2001 as a joint initiative of the Department of Justice, Legal Aid NSW, Law Society of NSW and the NSW Bar Association. A recent survey showed more than 90 per cent of LawAccess users were highly satisfied with the help they received.



Heat stress and heat-related illness

Extreme heat can affect anybody. Those most at risk are older people, young children and people with a medical condition.

Heat stress occurs when our body is unable to cool itself enough to maintain a healthy temperature. Normally, the body cools itself by sweating, but sometimes sweating isn't enough and the body temperature keeps rising.

Heat-related illness can range from mild conditions such as a rash or cramps to very serious conditions such as heatstroke, which can kill. Overexertion in hot weather. sun or bushfire exposure, and exercising or working in hot, poorly ventilated or confined areas can increase your risk of heat stress. Heat can also make an existing medical

condition worse, for example heart disease. People most at risk of heatrelated illness

Anyone can suffer from heatrelated illness, but those most at risk are:

* People over 65 years, particularly those living alone or without air conditioning * Babies and young children * Pregnant and nursing moth-

* People who are physically

unwell, especially with heart disease, high blood pressure or lung disease * People on medications for

-related illness There are many factors which can cause heat stress and heatrelated illness, including: **Dehydration** – to keep healthy, our body temperature needs to

stay around 37°C. The body cools itself by sweating, which normally accounts for 70 to 80 per cent of the body's heat loss. If a person becomes dehydrated, they don't sweat as much and their body temperature keeps rising. Lack of airflow – working in

hot, poorly ventilated or confined areas Sun exposure – especially on

hot days, between 11am and 3pm

Hot and crowded conditions people attending large events (concerts, dance parties or sporting events) in hot or crowded conditions may also experience heat stress that can result in illness.

Bushfires – exposure to radiant heat from bushfires can cause rapid dehydration and heatrelated illness. Bushfires usually occur when the temperature is high, which adds to the risk. Symptoms of heat-related illness

It is important to know the signs and symptoms of heat exposure and how you should respond. Symptoms vary according to the type of heatrelated illness. Babies and of restlessness or irritability and delirium, coma and seizures. have fewer wet nappies. Older people may become lightheaded, confused, weak or faint.

Heat rash - sometimes called 'prickly heat', this is a skin irritation caused by excessive sweating. It can occur at any age, but is most common in young children. It looks like a red cluster of pimples or small

Heat cramps - these include muscle pains or spasms, usually in the abdomen, arms or legs. They may occur after strenuous activity in a hot environment. when the body gets depleted of salt and water. They may also be a symptom of heat exhaus-

Dizziness and fainting - heatrelated dizziness and fainting results from reduced blood flow to the brain. Heat causes an increase in blood flow to the skin and pooling of blood in the legs, which can lead to a sudden drop in blood pressure. There can be a feeling of lightheadedness before fainting occurs

Heat exhaustion - this is a

serious condition that can develop into heatstroke. It occurs when excessive sweating in a hot environment reduces the blood volume. Warning signs may include paleness and sweating, rapid heart rate, muscle cramps (usually in the abdomen, arms or legs), headache, nausea and vomiting, dizziness or fainting

Heatstroke – this is a medical emergency and requires urgent attention. Heatstroke occurs when the core body

temperature rises above 40.5 $^{\circ}\mathrm{C}$ and the body's internal systems start to shut down. Many organs in the body suffer damage and the body temperature must be reduced quickly. 



Treatment for dizziness or fainting includes: * Get the person to a cool area and lay them down If fully conscious, increase fluid intake. **Heat exhaustion – treatment**

- Treatment for heat exhaustion includes:
- * Get the person to a cool area and lay them down * Remove outer clothing.
- * Wet skin with cool water or wet cloths. * Increase fluid intake if they are fully conscious.
- Seek medical advice.

Heatstroke - treatment

Heatstroke is a medical emergency and requires urgent attention:

* Call triple zero (000) for an ambulance * Get the person to a cool, shady area and lay them down while you're waiting for emergency medical

help. * Remove clothing and wet their skin with water,

fanning continuously. * Do not give the person fluids to drink.

* Position an unconscious person on their side and clear their airway.

* If medical attention is delayed, seek further instructions from ambulance or hospital emergency staff.

Prevention of heat-related illness Prevention is the best way to manage heat-related illness. Some tips to prevent heat stress include: * Drink plenty of water – you need to drink more during hot weather, regardless of how active you are.

even if you don't feel thirsty (check with your doctor if you are on limited fluids or fluid pills). Avoid alcohol or drinks that contain lots of sugar. Don't have extremely cold liquids, as they may cause stomach cramps.

* Avoid exposure to heat - stay out of the sun as much as you can,

* Protect yourself outside - if you must be outdoors, remember to protect vourself from the sun 'slip, slop, slap' by covering exposed skin with lightweight clothes, using sunscreen and wearing a hat, 'seek' shade and 'slide' on sunglasses.

* Plan ahead - too much activity on a hot day can lead to heat stress. If you can, restrict activity to cooler parts of the day. Avoid physical activities like sport, renovating and gardening.

* Don't leave kids, older people or pets in cars even on cool days, cars can heat up to dangerous temperatures very quickly. People or pets that are left unattended in parked cars for even a few minutes are at risk of serious heat-related illnesses and possibly death. Never leave kids, older people or pets in a parked car, even if the windows are left open a fraction.

* Take it easy – rest often and, whenever possible, stay indoors or in the shade.

* Stay cool – and keep air circulating around you. Draw your blinds or curtains and use a fan or air conditioning if possible (if you don't have air conditioning, consider visiting an air-conditioned shopping centre or public library). Keep yourself cool by using wet towels, putting your feet in cool water and taking cool (not cold) showers.

* Keep up your energy levels – eat smaller meals more often and cold meals such as salads.

* Check in on others – keep in touch with older, sick or frail family, friends and neighbours who may need help coping with the heat, especially those who live alone. Call them at least once on any extreme heat day.

Fair Trading launches strata hotline

NSW Fair Trading have announced that there is a strata hotline to take consumer calls on the new

reforms. The reforms have taken five years of public

consultation, including over • 3,000 submissions, and contain more than 90 changes to the law. To help consumers deal with the changes, a hotline has been set up on 1800 214 023.

NSW Fair Trading Commissioner Rod Stowe said: "With major updates made to the existing strata laws, our Contact Centre Officers who specialise in strata law have been familiarising themselves with the changes to ensure that they are equipped to provide the right assistance and advice.

"These changes will

improve strata living for over two million people who own, live or manage strata schemes across the state.'

Key changes to the reform include:

- Making it easier for owners to complete cosmetic and minor renovations
- Making it easier to hold meetings and vote on decisions using modern forms of communication
- New options for addressing issues of parking, pets and smoke drift
 - Ensuring tenants can play a valuable role in the life of their strata scheme
 - A new collective sale process enabling owners to jointly sell and/ or redevelop their strata scheme, which the NSW Land and

Environment Court must ensure is 'just and equitable' for the owners.

Strata renovations under the new laws

Jane Crittenden, a specialist strata lawyer, states that one of the most significant changes in the new strata reforms is the new method of regulating renovations, additions and alterations to units.

Under the new Act, brought in on 30 November 2016. new categories of works affecting common property have been created. These include "cosmetic work by owners" (Section 109), "minor renovations by owners" (Section 110) and other works affecting common property (Section

111).

Cosmetic work Cosmetic work allowed to be carried out in a competent and proper manner, without approval of the owners corporation, includes:

- installing hooks, nails or screws to hang a painting or things on walls
- installing or replacing handrails filling minor holes and
 - laying carpet

cracks in internal walls

installing or replacing built-in wardrobes,

internal blinds and curtains and other work prescribed by the by-laws passed by the

owners corporation. However it does require an owner to ensure that any damage caused to any part of the common property is repaired.

Section 109(5) specifies work not included. This is defined as "minor renovations" in Section 110. and includes work: * involving structural changes that affects the external appearance or safety of a lot * that affects the fire safety systems, waterproofing or plumbing or exhaust system

of a building in a scheme * reconfiguring walls, and any other works defined by the Strata Schemes Management Regulation 2016 ('the Regulation') as not being cosmetic work. **Minor renovations**

Minor renovations are defined in Section 110 of the Act, and are supplemented by additional items set in Regulation 28. A special resolution is not needed to carry out minor renovations to common property in connection with an owner's lot. An ordinary resolution at a general meeting is required to approve minor work, and approval may include conditions imposed by the owners corporation. However an owners corporation cannot unreasonably

withhold its approval. Minor renovations are defined non-exhaustively and there may be items THE NEWS Issue 445 WEDNESDAY 14 Dec 2016 9 10 which are not ex-The Act also imposes an

pressly listed in the Act or Regulation. The items listed in Section 110(3) are:

* renovating a kitchen * changing recessed light fittings

* installing or replacing wood or other hard floors installing or replacing wiring, cabling, power, or access points * work involving reconfiguring walls * any other work prescribed by the Regulation. Some items are very general descriptions which could range from limited to quite extensive work. **Regulation 28 supplements** Section 110(3) with a number of additional works which are considered minor renovations. These include removing carpets to expose wooden or other hard floors, installing a rainwater tank, clothesline, reverse cycle air-conditioner, solar panels, solar hot water system, heat pump or ceiling insulation. Section 110(4) specifies the information which an owner must give to an

owners corporation about proposed minor renovations before seeking approval. This includes details of the work, plans, duration and times of the works, the people carrying out the work and their qualifications, and arrangements for removal of rubbish and debris.

obligation on the owner to repair any damage caused to the common property. Section 110(5) reserves the right to an owners corporation to pass a by-law to specify work which it considers to be a minor renovation, and permits the owners corporation to delegate its functions under Section 110 to the strata committee. Excluded from the definition of minor renovations is cosmetic work, waterproofing, structural changes, changes to the external appearance of a lot, work which requires approval of a by-law.

The definition of minor renovations includes reconfiguring walls, but excludes structural changes and this could cause tension and give rise to disputes between owners and owners corporations. Works affecting common property other than cosmetic renovations and minor renovations are dealt with by Sections 111 and 142 of the Act. A by-law approved by special resolution is required for

such works. **Common property rights** by-law

A common property rights by-law is defined in Section 142 of the Act and discusses the right of exclusive use and enjoyment, or special privileges of the whole or any specified part

of the common property. Section 144 of the 2016 Act requires a by-law to specify whether the owners corporation or lot owner is responsible for the maintenance and serviceable repair of the common property or relevant parts.

Registration of by-laws

Section 141 of the Act provides that a change to the by-laws of a strata scheme has no effect until written notification is registered with the Registrar-General of the Department of Lands. This must be done within six months of the date of the passing of the resolution to make the by-law. The six -month time limit is a significant reduction in time from the present requirement of two years and applies to all by-laws

approved. **Tribunal powers**

In the event of uncertainty if proposed works are cosmetic or minor renovations, an owner may seek a declaration from the Tribunal (Section 127). Presumably, it would be necessary to seek such an order if proposed works an owner considered cosmetic were considered by the owners corporation to be a minor renovation. Section 126 of the Act also sets out the Tribunal's powers to permit an owner to carry out alterations and repairs to common property and other property.

Working together to deliver garden organics

service In addition to general waste bins and recycling bins, residents in Maitland, Cessnock and Singleton Local Government areas will soon be supplied with a new bin sporting a lime green lid as part of the roll out of a kerbside garden organics collection service. The roll out of the bins will start in January and will take about seven weeks. The first collection will commence on Monday 6 March 2017. Residents will be able to use the bins to dispose of a range of garden organics including grass clippings, prunings, weeds, leaves, and sticks and small branches. The material will then be processed into mulch and compost that can be used on local parks, sporting grounds and agriculture rather than using up scarce landfill space.



Council's Manager Development and Environment David Simm says, 'Last year it is estimated that 6,500 tonnes of garden organics was disposed of through our garbage bins and there has been a steady increase of this type of material going to landfill over the past few years.

Working together, the three councils were successful in obtaining a \$2.2 million grant from the NSW Environment Protection Authority as part of the 'Waste Less, Recycle More' initiative and it has funded the purchase and supply of the bins, and also means the service will be provided to ratepayers at no extra cost. Council is also committed to education and spreading the message about what garden

organics actually is. 'It is important to only put your garden organics into the new bin as this ensures contamination levels are low and the compost generated from the collected materials is of high quality', Mr Simm said.

'Up to a quarter of household garbage bins in our region are currently made up of garden organics. The service will make a big difference to our environment, increase the lifespan of our landfill sites and provide a cost effective expansion of our waste management services that will take us into the future.





A Brief History of Seven Killings by Marlon **James review** - bloody conflicts in 70s Jamaica Kei Miller

The Jamaican novelist Marlon James has written three books to date - a kind of triple-jump feat, though that metaphor isn't quite appropriate when one considers the extraordinary length of the leap he has taken between each book. His first novel, John *Crow's Devil*, established him as an interesting local writer with an imagination markedly different from

But John Crow's *Devil*, a small novel of hardly 200 pages, did not prepare anyone for what was to come next: The Book of Night Women. Easily one of the best Jamaican novels ever written, The Book of Night Women, a slave narrative, is an incredible feat of plotting, pace and language. While it embraces a Jamaican dialect, it also established James as an international star. In every way, it is a bigger novel than John Crow's Devil; epic in scale, and written with far more narrative power and lvricism. James's new novel, A Brief

History of Seven Killings,

of Bob Marley, who is referred to throughout as "the singer", and its aftermath. But perhaps more importantly, it tells the story of Jamaica in the 1970s and early 80s, when the guns flooded in, CIA agents took up residence, and the island went through one of its most violently defining moments. It is a story worth telling, and a story about Jamaica that doesn't only take place in Jamaica. If one were to be curmudgeonly, one might say that A Brief History is slightly more impressive for its ambition than its accomplishment. In John Crow's Deviland The Book of Night Women, the ambition and the accomplishment were perfectly matched. A Brief History, however, is sometimes more impressive than it is easily enjoyable - a difficult book with a stop-start structure that doesn't quite sweep you up in the way the single narrative voices of the previous novels did.

Bakhtin saw the novel as the genre of polyphony, incorporating and orchestrating several competing voices. James seems to take this philosophy to heart, even extending it, and so in A Brief History of Seven Killings we find a novel of cacophony. The cast of characters presented at the beginning of the book totals around 75, several of them jumping in and out to

tell their pieces of the story. The book brings together a variety of Jamaican experiences, which isn't to say that these experiences are local or parochial. James's invented ghetto of Copenhagen City, where many of the book's murders are plotted and take place, is worth a moment's consideration. Though the ghetto's name is an invention, it is reminiscent of actual places within the urban sprawl of Kingston, places such as Tel Aviv, Spain, Gaza and Angola areas that exist within Jamaica but also refer to a wider world of conflict in which it participates. The names of some ghettoes, such as Tivoli Gardens, seem especially ironic, with the inspiration of the original being so far removed from the killing field the place has become.

James was born in Kingston, Jamaica, to parents who were both in the Jamaican police: his mother (who gave him his first prose book, a collection of stories by O. Henry) became a detective and his father (from whom James took a love of Shakespeare and Coleridge) a lawyer. James is a 1991 graduate of the University of the West Indies, where he read Language and Literature. He received a master's degree in creative writing from Wilkes University (2006). Career

James has taught English and creative writing at Macalester College since 2007. His first novel, John Crow's Devil - which was rejected 70 times before being accepted for publication - tells the story of a biblical struggle in a remote Jamaican village in 1957. His second novel, The Book of Night Women, is about a slave woman's revolt in a Jamaican plantation in the early 19th century. His most recent novel, 2014's A Brief History of Seven Killings, explores several decades of Jamaican history and political instability through the perspectives of many narrators. It won the fiction category of the 2015 OCM Bocas Prize for Caribbean Literature and the 2015 Man Booker Prize for Fiction, having been the first book by a Jamaican author ever to be shortlisted. He is the second Caribbean winner of the prize, following Trinidad-born V. S. Naipaul who won in 1971. James has indicated his next work will be a fantasy novel, titled *Black Leopard*, Red Wolf. It will be the first in a series

So too, James's Copenhagen City is no Why you don't transfer longer a peaceful Scandinavian landscape when it is placed in the hot tropics. James often brings the international within a national space. But most exceptional is his bringing together of a variety of Jamaican and American accents, and not for polite conversations, but to enter into the most brutal and bloody conflicts. In the wonderfully complex character of Josey Wales, we see James managing a range of language not only between characters but within a single character. Josey tells us of his meeting with CIA agents: "I don't tell him that yo tengo suficiente español para concocer que eres la más gran broma en Sudamérica. I chat to him bad like some bush naigger and ask dumb question like, So everybody in America have gun? What

Dirty Harry to the Jamaican branch? hee hee hee." If the scope of James's talent has grown from book to book, his imagination is more consistent – that tendency to inhabit the dark and gory places, and to shine a light on them. Despite its title, this isn't a brief novel and neither are there a mere seven killings. Readers will flinch many more times than that. When reading reviews of Night Women, James apparently became bored with comparisons to Toni Morrison; and with A Brief History, he's got bored with comparisons to Quentin Tarantino. But it is hard not to see the strength of that comparison. This is a novel that explores the aesthetics of cacophony and also the aesthetics of violence.

How long do they plan to provide updates? My last TV lasted 20 years (granted it appears that my new one, NOT SMART, won't last anywhere that long)'



You make some excellent points. And, yes, manufacturers can update smart TVs. A smart TV is really just a really big tablet that runs apps. The makers of those apps can also update them. But just as with a tablet, it's up to the manufacturer how long they will continue to provide updates. Updates are available via the Internet, just like with any tablet. For example, on a Samsung Smart TV, you'll find a Support option on your menu. You can go there and choose a Software Update option.

That's why a device like Roku or Fire TV can be a better option. You get apps and Internet access just like a smart TV, but they are fairly inexpensive to replace if they break or if technology changes.

As far as how long your TV will last, only time will tell A Million Google Play Accounts Hit By Fraud

Around a million Google accounts have been hit by hackers taking advantage of a big Android flaw. They're using a malware called Gooligan to go after Android devices The Gooligan malware comes hidden in Android apps. Once installed on your device, it steals your account information and then installs apps on your device. The malware was first discovered by Check Point security researchers last year. Check

Point says it has informed Google about the issue. This malware can gain access to your email, Google Drive documents and files, and your photos. Why are they doing it? To help increase ad money from those apps. That money goes to the app developers. This malware even leaves phony positive reviews for these apps. The apps get a strong positive rating that helps them look legitimate.

Check Point released this graphic to explain how the malware works

HOW THE GOOLIGAN CAMPAIGN WORKS



The malware affects devices running Jelly Bean, KitKat, and Lollipop. That makes up around 75% of devices in use. This malware gets onto your device when users install apps from third -party app stores. Often times these third-party stores will offer free versions of paid apps that look legitimate. They can also be installed when hackers use phishing scams to trick you into downloading.

Apple Offers To Replace iPhone Batteries

A lot of iPhone 6s users started experiencing an annoying shutdown issue after updating to iOS 10.1. Their phones kept shutting down with plenty of battery life left. Now, Apple is offering free replacement batteries for phones with a certain range of serial numbers. Apple points out that this is not a safety issue, just an annoyance.

iPhone 6s Program for Unexpected Shutdown Issues



If your phone is eligible, you can take it to a local Apple authorized service provider or an Apple Store for battery replacement. You need to deal directly with Apple, wireless providers aren't taking part in the battery replacement. You will need to check with the Apple service provider or store and make an appointment for the replacement.

Though I would caution against using your dog and his birth year for passwords. That's the kind of information that people can find out rather easily and pet's names and family birth years are among the first things a hacker would try when guessing your passwords.

THE FOUNDER

BOUT The backstory behind the burger behemoth becomes digestible but unfulfilling drama boosted by its lead performance. SARAH WARD



It all starts with an order for six multi-spindle milkshake mixers, the kind of item that travelling salesman Ray Kroc (Michael Keaton, *Spotlight*) usually has trouble selling. After calling the Californian eatery in question to confirm - and discovering not only was the purchase correct, but that the buyer would actually like to increase the quantity - Kroc incredulously, excitedly jumps in his car, heads to San Bernardino, spends 55 cents on a burger, fries and soft drink served straightaway in disposable packaging, and experiences the revolutionary-at-the-time fast food experience that is McDonald's circa 1954. Soon, he's taking a tour with owners Mac (John Carroll Lynch, Miracles From Heaven) and Dick (Nick Offerman, TV's Fargo), discovering their Speedee service system, envisaging expansion potential, and talking franchises. And so, the bustling burger behemoth consumers know and eat at today began to take shape. Stamped with a title cognisant of the role Kroc endeavours to manoeuvre himself into, as well as nodding to the formative years covered in the narrative, The Founder is an origin story, but there's no superheroes in sight. Rather, director John Lee Hancock (Saving Mr. Banks) and writer Robert D. Siegel (*Turbo*) track Kroc's plan to use the McDonald brothers' business as a launching pad for the success he feels he deserves. Grounding his efforts in

mentions of years spent struggling to spruik different Founder aims to expose products - and evidence of his strained dealings with banks, the joke-like status he's held in at his country club, and the obvious discontent of his largely neglected wife Ethel (Laura Dern, Certain Women) can't paint Kroc as a battler, though. Here, the rise of the golden arches is mirrored by his ascension, capitalising upon someone else's ingenuity and innovation in meeting hungry customers' needs to spark growth, greed, ambition and ruthlessness. Indeed, Kroc may sit at the centre of the feature: however, other than

recognising his determination and never-take-no-foran-answer attitude, this isn't a flattering tale. It is a familiar one, though, once again taking a corruptionsized chunk out of the American dream — and slathering what's left with desperation and callousnesslaced sauce. And yet, while slick editing by Robert Frazen (The Family Fang), glossy imagery shot by John Schwartzman (Jurassic *World*) and colouring the visuals in shades reminiscent of the brand at its centre all help shape the largely explanatory, expository script into something engaging enough, the McDonald's -related minutiae, bickering and backstabbing overwhelms any focus on character. In a film intent on using one company and the figure that thinks he's behind it as a case study with wider societal parallels, that might be fitting; however, there's an imbalance in Hancock and Siegel's recipe. Wanting to have their meat,

and eat it too, The the backstory most people won't know, pick out some of the juicy details, and let audiences gleefully munch away on a shiny piece of entertainment. And, with the assistance of Keaton, who is tasked with jittering his way to conveying Kroc's external perseverance and internal vulnerability, it tries to balance its overt packaging with hints of deeper flavour. In both cases, slickness wins out over texture, and ease over complexity, in a movie uncertain of the right tone or stance to adopt. Keaton fares much better than the film he's in — in fact, any subtleties The Founder boasts stem from his performance — but the end result remains lightweight rather than filling.

Take a number of small but blatant choices as examples: having Keaton often recite Kroc's spiels to camera, favouring simplistic contrasts between the quality-overcash mindset of the McDonald siblings and the more-is-more position of their new partner turned corporate hijacker, and trying to bring the feature to an end with a wink rather than any real bite all speak of an effort selling a concept rather than actual contemplation or a statement. Or, perhaps that's the message that Hancock and Siegel are happy to convey, with smooth but empty consumerism pursued at any cost begetting a digestible but insubstantial film offering more of the same. **Rating:**

When Greg Norman passes on he was one of your best friends and you can't believe that someone so close to you has gone.

My grandfather used to play cricket with Don Bradman. When he was a kid he rode Phar Lap around the stables in Kensington. In fact, he hit a six playing with Don Bradman while riding Phar Lap if my memory serves me correctly. Sydney University must have enrolled 30 times the average intake of students during the years in which Clive James attended. Presently, Andrew Johns has more "good mates" than anyone I know.

Mel Gibson isn't far behind. Russell Crowe, Kylie Minogue and Nicole Kidman seem to be related to a surprising number of people and Hugh Jackman attended more schools than are actually registered in Australia.

The wine industry, you can appreciate (or perhaps not) attracts all types. Let's just say that the social implications involving anything to do with good bottled wine is extremely appealing to many. From the growing of the grapes through to the appraisal and consequent ingestion of wine, it is an exciting journey for all of us to explore. Again, this need for an attachment to a famous face appears in memories and myths and stories alike. Within the industry, there are a handful of wine identities who certainly command respect for their chosen strengths. One man, however, stands alone when Australian wine drinkers strike a motion to tell the world the stories of their mystic journey with the magical nectar of the vine. The chap I speak of lives in our area. He even reads the Branxton-Greta News as you are doing now. He is without doubt the most celebrated wine identity in Australia

and one of the top wine figures in the world. From a male point of view, Len Evans is an easy guy to dislike. He is confident. He is smart. He has an extremely well modulated speaking voice. He is one of Australia's best golfers. He is one of Australia's best fisherman. He is one of Australia's most talented architects and interior designers. He is an expert in antiques and art and music. He is a world class chef. His knowledge and palate with regards to wine is unparalleled. He is good looking and women absolutely adore him oh my, I think I'm going to be sick with envy. Not a day goes by in my life when Len's name is not mentioned. From a very young age, I can recall a million and one Len Evans stories being told in the Marsh Estate cellar door.

Len Evans, you see, has amazing appeal to modern mankind and while we attach his famous face to wine, Len is busy attaching wine to his food, his art, his antiques, his architecture and the like. Len Evans' vision for his endeavours is legendary. Len is not famous for throwing or kicking a piece of leather around a ball park and exclaiming that "The boys played good - yous played hard" after the game before shooting an advertisement for a pool company or menswear store. Far, far from it. It is refreshing to know that there is truly someone out there who can venture in from a round of golf, open a bottle of the world's finest wine, cook a five star meal while listening to an appealing array of music in the comfort of a room which resembles a European palace, while casually letting the answering machine take a phone call from the Prime Minister.

I am not trying to feed Len's ego, there are enough people doing that already. I'm trying to paint a picture of a figure with whom people want to associate themselves. My point is this -Len Evans makes James Bond look like a red-necked hick

from Wilcannia. I politely nod and smile as if it's one of the all time great stories. The narrator

then sits, feeling the importance that he has rubbed shoulders with the best. I understand this mentality and even as a winemaker, I often drop Len's name to lift the Hunter's profile (why would the king of Australian wine live in the Hunter if it wasn't the best?).

Occasionally, however, I strike someone who struts into the cellar door with the sole intention of impressing a female accomplice. They do not intend to fork out a cent to buy any wine yet they taste everything twice and hammer the Len Evans stories around the room for hours on end. I remain polite until I sense they feel in complete control of the situation at hand - that of impressing - and then I enthusiastically announce that I will be seeing Len a bit later and promise to relay their regards as soon as I see him. It's amazing how many people forget their own name upon this request. They almost stutter as their face turns to beetroot. Odd, very

odd. When I was in Singapore last week, I was guest speaker at a wine dinner for about 45 people at an exclusive golf club. The majority of the crowd were younger than 40 or 45 and of Asian background. During my delivery I dropped Len's name and rambled on how good the Hunter was etc, etc. I got the feeling that everything I was talking about was so foreign to them I had to try and say something familiar. I went on..... "This wine here is a classic Hunter Semillon" I preached. They picked up their glasses and smelt and tasted the wine without a facial expression altering throughout the room. "This is one of my best mates Russell Crowe's favourite wines" I added, "he's a big fan of Hunter Semillon". The whole room "oooohhhhed" and "Aaaahhed" at his familiar name and they picked up their glasses smelling and tasting the wine with a renewed zeal."And Russell has always wanted to meet

Len Evans" I keenly added. Cutting a long story short, I sold more Semillon in one night than I would in a month and Russell Crowe and Len Evans then became the talking piece for the night. During the closing stages of the night an Australian chap turned up late to the dinner and approached me to apologise as he was stuck in meetings at work. I quickly summed up what the night had entailed when he announced without prompt that he was very familiar with Australian wine and started rehashing a Len Evans story. It went on for a while until his wife (who had been at the dinner the entire night) interrupted us and exclaimed that I was best friends with Russell Crowe. His face lit up and he excitedly told me that he and Russell's wife, Danielle, were great family friends. "What's your name again, I'll tell Russell I met you" he enthused.

I went a slight shade of red and curiously couldn't for the life of me

remember my own name. "I'll tell you what" I said with a wink "If you don't tell Russell I was here, I won't tell

Singleton report date 7 Dec 2016

Yarding 905 ~ Change 135 (Comparison Date 30/11/16)

Consignments lifted by 16%, with the quality offered remaining very mixed. There were well bred younger cattle, along with a selection of the plainer lower muscled lots. The younger drafts made up the bulk in the penning, with around 90 cows presented for sale. The overall market trend was firm, with breed and quality the only contributing factor with any price variations. The over 200kg vealer steers to the

restockers ranged from 353c to 433c, as the lighter end topped at 471c/kg. The equivalent weighted heifer portion also to restocker interests made from 321c to 386c/kg. Yearling steers trended firm, as the medium weights sold from 325c to 354c/kg, with the restockers securing the bulk in the competition. Yearling heifers also sold at similar prices, week-on-week. The prime conditioned younger drafts to the butchers topped at 380c/kg. Lot feeders and restockers purchased the younger grown steers at 279c to 310c, as the heavier bullocks to slaughter reached 280c/kg. Cows overall maintained firm prices, however the plainer 2 scores lifted 8c to average 214c/kg. The better covered 3 and 4 score heavy weights ranged from 218c to 236c/kg.

Scone report date 6 Dec 2016

Yarding 748 ~ Change -489 (Comparison Date 29/11/16)

Quality overall was very mixed, with a greater percentage of the plainer younger cattle offered compared to the last market. Consignments slipped, with the bulk in the penning comprising the younger drafts. Vealers were reduced in number, as good numbers of the yearlings were in the offering. There were around 103 cows, with some high yielding pens offered. The usual buyers competed in a generally firm market; however the vealer steers went against the firm trend and eased 15c/kg. The over 200kg vealer steers returning to the paddock ranged from 335c to 392c/kg. The same weight heifer portion also to the restockers and backgrounders remained firm at 330c

to 378c/kg. The yearling steers all sold to a firm trend, with the medium weights to the restockers and lot feeders making from 310c to 350c/kg. The yearling heifers sold to solid competition, with prices remaining unchanged week-on-week. The prime conditioned young cattle to the butchers improved in yield and quality and these topped at 379c/kg. The heavy weight grown steers to slaughter showed little change in price and ranged from 250c to 278c/kg. The best heavy weight heifer topped at 270c/kg. Cows maintained firm prices, as the plainer 2 scores averaged 220c, with the better covered 3 and 4 score heavy weights making from 205c to 240c/kg. The best heavy weight bull reached 235c/kg.

TRLX Tamworth report date 5 Dec 2016 Yarding 1341 ~ Change -489 (Comparison Date 28/11/16)

Significantly hotter conditions over the weekend saw the numbers reduced by almost 500 head this week. Yearlings made up the bulk of the offering, with a fair supply of well finished heavy grown steers and

some good cows. The quality and condition of the cattle overall was mixed, with very few straight lines available. The usual buyers were in attendance. Demand for feeder cattle remained strong, with both the yearling steers and heifers remaining firm. Although quality driven, there were a few odd sales that finished slightly dearer, as the heat combined with drying feed stocks saw demand from restockers a little weaker. This resulted in medium and heavy yearling steers selling to a slightly cheaper trend, of which continued into the light and medium weight heifer yearlings returning to the



paddock. The well finished yearlings suitable to the trade also sold to a cheaper trend. There was little but quality related price change for the heavy grown steers and heifers. Medium weight cows (2 score) sold to a slightly dearer trend, with quality and yield potential a little higher. There was little change in the market for the balance of the cows.

Cattle projections

The Australian cattle market will find itself battling conflicting forces for the remainder of 2016.

From a cattle supply point of view, numbers over the coming two years will fall to levels not seen in more than twenty years. This alone will more than likely stimulate strong competition between restockers, feedlots and processors for the limited availability.

The national herd is estimated to fall to 26.2 million head by 30 June 2016, before rising slightly again in 2017, to 26.3 million head.

Working to partly offset the projected 18% year-on-year decline in adult cattle slaughter for 2016, at 7.4 million head, will be the expectation that average carcase weights will increase considerably. This assumption is based on much lower stocking rates, a greater proportion of lighter northern cattle exported live, a higher proportion of cattle on feed and fewer female cattle processed.

Beef and veal exports are expected to fall as a result of lower production, not due to waning demand. The prediction of the A\$ to average between 66-69US¢ is a significant positive, but needs to be balanced against the heightened competition from Brazil in many markets, the expectation of high US poultry and pork production, higher year-on-year US beef production and significantly weaker US beef markets compared to 12 months ago.

Real friends are "with-us" even in our absence and "being-with" in spirit or in person is closely allied with "being-for". Today's gospel affirms "being-with" as God's Christmas gift to us. The first chapter of Matthew's gospel tells us that the expected child Messiah or Christ-child is 'God-with-us", Emmanuel. The gospel will conclude with the assurance of the resurrected Christ, "And remember, I am with you always, to the end of the

age" (Matt 28:20). As we

celebrate the successive

liturgical seasons in the

coming year, we shall have the opportunity to enter into Matthew's story of God-with-us in the person of Jesus and to live out the pattern of that story more fully in our own lives. There is no angelic annunciation to

Mary in Matthew's gospel, no embrace of an expectant mother. There is no inn or innkeeper, no shepherds or shepherds' fields. These are all features of Luke's tableau. Matthew brings different features and different characters to centre stage. Chief among Matthew's characters is Joseph who, like Joseph of old, receives God's revelation in a series of



dreams. The angelic annunciation in today's gospel is to Joseph: he is not to be afraid, but to accept the extraordinary ways of God which will bring salvation for God's people. Joseph trusts the word of God's messenger: he abandons his own plans and lives by faith in God. If we try to harmonise the different gospel accounts of and to draw us into the

birth of Jesus, we may lose some of the wondrous mystery of the feast we celebrate. If, on the other hand, we attend to the awesome truth that God is with us, then we might be more attentive to how we are with one another. We may also come to acknowledge our

presence or "being-with" as a precious Christmas gift. Those who distance themselves from the community of life run the risk of succumbing to fear and of losing the joy in living.

Acceptance of the truth that God is with us has the potential to drive out fear the events surrounding the deepest mysteries of life.



Is it True you have to Use it or Lose It? 'If you want to retire happy, great health is important. The foundation for all happiness lies in health. Physical, mental, or spiritual health - you must use it or lose it!"

Ernie J Zelinski "Use it or Lose It". How many times have you heard that popular saying? Henry Ford said it about money, Richard Bach referred to perspective, and even health funds tell you "use it or lose it". But as we get older for some reason applying this cliché to our health and



fitness seems to get harder and harder. Is this an inevitable part of the ageing process? Or is it all in our head and "it gets harder as you get older" is just a saying to make us feel better for not doing as much as we get older? As I have gotten older (I'll be forty eight next year) I have pondered this question a lot. My weight (and my fitness) have gone up and down over the years, and each time I have gotten fed up enough to do something about it, it just seems harder, and takes a little longer to see results. Perhaps it is because as I get older I forget how hard it was last time. Or maybe it is because as we get older we have so many more responsibilities and activities vying for our attention? Or maybe it really IS harder. Just like younger adults, there is a wide range of health and fitness in people over 45 years of age. You may have been training for quite some time and because of this your health may be excellent. Other people the same age may have quite low levels of fitness. Either way, the effects on health which result from a low level of mobility or fitness are very similar to the effects on other (younger) age groups. These include postural challenges brought on by tight muscles, poor balance from a lack of core stability, heart problems or high blood pressure, and diabetes. As with all age groups, one of the easiest ways to address or prevent these health conditions is with regular exercise, including cardio exercise (which raises your heart rate) as well as resistance training (for example strength exercises using light weights). But even if you have been exercising your whole life, as you get older there are definite physical changes in your body which increase the challenge of maintaining your fitness. For example, as you get older your maximum Heart Rate (HRmax) decreases. My HRmax (calculated by using the formula 206.9-(0.67x47)) is 188, a full 7 beats per minute less than it was 10 years ago. This does not sound like much, but when I am trying to make sure I exercise safely for weight loss, or when I am trying to improve my cardio vascular fitness by working within a certain heartrate "zone", it is important to know. And it explains why working at a certain level can be harder as I get older! Changes to your lungs and the muscles around your lungs also means it takes more effort to breathe in and out, and your respiration rate increases as you get older, affecting the amount of air which moves in and out of your lungs when you exercise. This is turn affects the amount of oxygen available to go into your blood stream. Another effect of getting older is a reduction in blood flow and along with it a decreased ability to dissipate heat via sweat as blood flow to your working muscles is reduced. Your metabolic rate also changes as muscle mass decreases so yes, you may be putting on body fat even if your diet hasn't changed! These challenges are all in addition to the more commonly known health conditions such as osteoarthritis (where the cartilage in your joints breaks down), osteoporosis, and rheumatoid arthritis (inflammation of the joints). Your muscle tone also changes (affecting the stability of your joints), and reflexes and movement can become slower due to natural changes in your nervous system. I can now hear you all asking "well, what's the point??". Aging is inevitable, so if a gradual deterioration in muscle tone, joint movement and flexibility is a natural consequence, why should I bother exercising? The answer is that exercising regularly can help counteract the natural effects of ageing. Exercise can prevent physical setbacks, and improve your mental health as well. In fact, it can be argued that exercise becomes MORE important as you get older. Keeping your muscles strong helps your joints, keeping your heart and lungs working decreases your risk of cardio pulmonary disease, and there studies which show that regular exercise can reduce your blood are many glucose levels and minimise your risk of diabetes. Staying (or becoming) active as you get older can also be a great social outlet. It can also be a great way to "switch off" the worries of the day, if only for thirty minutes. You are not imagining it when you think that exercising is getting harder as you get older, even if you have always been reasonably active. The most important thing to remember is to take into consideration the physical changes occurring in your body as you get older, and that you really do have to "use it or lose it".
