Objections to 'Huntlee' decision





Cessnock City Mayor Jay Suvaal said Councillors were standing with the community in regard to Urban One lots at Huntlee.

Cessnock City Councillors have resolved to lobby the NSW Minister for Planning, Anthony Roberts, to reverse an approval by the Department of Planning and Environment to allow allotments as small as 217m2

The application by the developer of Huntlee to amend the approval to allow for a new housing lot type known as Urban One has been approved by the State Government. An Urban One housing lot allows for smaller residential lots of between 217m² and 354m². These lots would accommodate compact dwelling types and will be located around the commercial centre and proposed school site at

Community engagement undertaken in regard to proposed changes to the Development Control Plan for Huntlee showed strong opposition to Urban One lots. Chief among concerns was parking and traffic.

Cessnock City Mayor Jay Suvaal said Councillors were standing with the community in regard to Urban One lots at Huntlee.

"The community has raised a number of valid concerns in regard to parking, traffic, and amenity," Mayor Suvaal

"There are also concerns about the lack of access to educational facilities and healthcare and the impact this would have by allowing further intensification of development at Huntlee.

"As local people, we know what is best for our community and we will do everything within our power to urge the State Government to reverse this decision.

"I am encouraging the community to speak up on this one by writing to the Minister." Council will also write to the Member for Cessnock Clayton Barr asking him to make representation to the Minister to have the decision overturned.

A spokesperson for LWP the 'Huntlee' developers said that Huntlee has been working with Council Officers for some time on this proposal. "We are actively seeking engagement with the Mayor and Council to better understand and collaboratively work through any issues they may have," he said.

The official announcement that Peree Watson from Branxton is the endorsed ALP candidate for the seat of Upper Hunter for the forthcoming state election was made on Saturday 12th November at Rose Point Park in Singleton.

With a glitterati of ALP MP's, a shadow minister, ALP aficionados' & family the official announcement and campaign launch was made by the Shadow Minister for the Hunter Yasmin Catley

On accepting the endorsement Peree said that she feels with a change in the boundary which now includes Branxton and not the Liverpool Plains that she can win the seat for the ALP.


The seat has been held by the Country Party/ Nationals for more than a 100 years.

"Looking at all the statistics on the seat I believe the ALP can take the seat from the conservatives," said Peree.

The seat of Upper Hunter has undergone a redistribution for the state election on March 25th 2023 with Branxton, north of the railway line, now included in the National Party held seat. The seat now goes from the Great Dividing Range in the north to Dungog, Gloucester in the east with the two main urban areas being Muswellbrook & Singleton.

The new boundaries makes the Upper Hunter the third most marginal of the 47 seats the Coalition government would have in the 93-seat lower house. National Party Upper Hunter state MP David Layzell MP will have his margin of 2.6 per cent cut to a nominal 0.5 per cent after the latest redistribution adopted by the NSW Electoral

Commission.

There has always been a different outlook on life between country people and city people. Poems by Banjo Patterson and Henry Lawson chronicled this difference 150 years ago and were accepted long before that. Life on the land and in country towns which service rural people requires acceptance of uncertainty and risk city folk rarely experience. Any exposure city folk have to the vagaries of country life is of having family or friends in the country and what the media portray, which is usually some disaster. Take your pick for plague, flood, droughts, fire, commodity prices or suicide. The good news stories get little attention. Thank goodness for the ABCs Landline, but how many people watch it? Most Australians know the different expectations between rural and urban populations, reflected in how they vote at election time. Socialist parties such as Labor and the Greens hold the city seats. Rural seats vote Conservative in general. This means National, Liberal, One Nation, or some single-issue candidate thrown up by local issues not being addressed by conservative parties.

The balance of power revolves around areas not defined as urban or rural such as Sea or Tree change areas and the sprawling commuter belts strung out along rail and highway corridors.

Examples are the NSW Central Coast, South Coast and Southern Highlands, Blue Mountains and areas such as Boring Bay. People in these areas tend to vote for the latest fad ideology or re-tread sporting or media personalities. When things the Government are, or are not doing, impact financially on people, swings big enough to change parties occur. Country people have little expectations from the

Government if they are not interfered with and services such as drivable roads, schools, medical facilities, and communications are maintained. They generally provide their own security: power, water,

sewage and a roadside delivery box for essentials from town. Except for the local agronomist, they do not welcome bureaucrats wasting their time and telling them how to run their farms, enforcing access for mining companies, quotas for this and that and limiting water

The folk in the countryside vote for candidates and parties that reflect the above. For the last 15 years, no parties have provided sound representation worth having. Some individuals offer good representation but not being in the Governing parties their efforts get little support and even less attention from the media.

Only when an individual sells their soul and seeks the balance of power in a party can the independent or minor party member do much.

When this happened with the Gillard Government, the two independents, Rob Oakeshott and Tony Windsor, declared their support for Labor on confidence and supply in return for some legislative concession Thus, allowing Gillard and Labor to remain in power with a 76-74 minority government. However, Windsor and Oakeshott achieved very little for Australia, and I cannot recall what they did for their electorates.





Raising the BARR WE CAN MAKE A DIFFERENCE TO HOMELESSNESS

It is estimated that across the Cessnock LGA there are somewhere between 500-1,000 homes being used as short term rentals on platforms like Airbnb. Essentially these are houses that are empty 80% of the

time and occupied by short term renters (tourists on holidays) about 20% of the time.

Having a property that is rented out short term in this highly popular tourist area can be financially rewarding. For example, a nice clean 3 bedroom home might earn an investor \$40,000+ on an Airbnb listing. For comparison, this same home might earn an investor a smaller \$25,000 as a normal regular long term rental property. Some people in our community are doing very well investing in properties for the short term rental market. For some, this has allowed them to gather up 5 or 10 or 15 or more properties that are rented out with pretty high frequency. Good on them. They break no rules; they simply prosper through smart investing. But we do have a massive housing problem here in our community. We do have dozens and dozens of

people that are homeless and sleeping in cars, or on streets, or couch surfing at various friends' homes. Its not that we have a shortage of houses, its simply that we have a shortage of houses on the long term rental market If just 1 in 10 of those

houses currently on the short term (weekender) rental market were returned to the long term renters, this would instantly provide 50-100 homes for people to live in long term. That would go a pretty long way toward fixing our local problem with homelessness Fingers crossed that some of those people that might own 5 or more short term rental properties might consider bringing one or two of them back to the long term



Rubella Symptoms & Causes Prevention

What is rubella?

- Rubella (or German measles) is an infectious viral disease of humans. Although in most people infection is mild, infection in early pregnancy can cause serious birth defects or miscarriage. What is congenital rubella syndrome?
- Congenital rubella syndrome occurs in up to 90 per cent of babies born to women who are infected with rubella during the first ten weeks of their pregnancy. Congenital rubella

syndrome can cause a

or mouth or by direct contact. Rubella is easily spread to people who have not been vaccinated or previously infected.

The time from exposure to onset of illness is usually 14 to 21 days. People with rubella are usually infectious from seven days before the rash occurs until four days later. Who is at risk?

Anybody who is not immune (either from past infection or vaccination) is at risk of rubella.


How is it prevented?

People with rubella should stay at home for at least four days after onset of rash, and avoid contact with

(especially men), may not be immunised. Vaccination against rubella is very important for women (and men) of child bearing age to reduce the chance of pregnant women coming into contact with, and contracting, rubella infection.


People born during or after 1966 who have not received two doses of rubella containing vaccine can access free MMR vaccine through their GP. People who are unsure if they have received two doses of a rubella containing vaccine in the past can safely be given another dose.

Former high-profile sports presenter for Nine News Sydney, Cameron Williams, has been charged with a domestic violence offence.

Mr Williams started his journalism career in 1984 as a newspaper cadet at Brisbane's Courier Mail, later joining The

Australian in its sports department before transitioning to television. He worked in a number of broadcasting roles until 2006 when he signed with Nine working on some of their flagship programs including Today, Nine News and Friday Night Football. His resignation from the network in March after 16 years came as a shock, with his departure effective immediately.

"It's with a heavy heart I have decided to resign from Nine. Leaving the best team in News is difficult and being part of that team an honour," Mr Williams said in an email to staff at the

"But I have struggled for years with increasingly poor health and I want to address that now for the sake of a more important team, my family.'

Director of News and Current Affairs, Darren Wick, thanked Mr Williams for his "significant contribution".

'Cam is leaving us to focus on his health and then to pursue

other opportunities that we look forward to hearing more about," he said.

Mr Williams is due to appear at Singleton Local Court this Thursday, November 24.

The symptoms of rubella may include a mild fever, rash, runny nose, conjunctivitis and often swollen lymph node. Aching joints are also common, especially in women.

The best protection against rubella is through vaccination with a rubella containing vaccine. In part of the Immunisation Schedule as MMR which protects against measles, mumps and rubella (MMR), and MMRV which also protects against varicella (chickenpox).

- MMR vaccine should be given to children when they are 12 months and MMRV at 18 months of age.



Stamp duty

Stamp duty is often one of the most significant costs associated with buying a house. Premier Dominic Perrottet said the scheme, dubbed 'First Home Buyer Choice", will be a gamechanger for first-home buyers. The legislation which passed last week covers all properties bought by first home buyers worth up to \$1.5m.

NSW first home buyers will soon be able to choose whether to pay an annual land tax instead of stamp duty. Currently,

land tax instead of stamp duty. Currently, homebuyers pay a tax in the form of stamp duty when they purchase a property. The one-off payment can add thousands of dollars to the overall cost of buying a property. Under the new legislation, first-home buyers will have the option to pay smaller annual amounts. Under the new program you can choose to instead pay an annual tax of \$400 plus 0.3 per cent of the land value (not the purchase price). If the first home buyers opt

the land value (not the purchase price). If the first home buyers opt for the annual land tax option, they are not locked into the property tax forever. If properties that are subject to the property tax are sold, they will not be locked into the property tax for subsequent owners. The new owners, if they are first home buyers, can then choose whether to pay the annual land tax or stamp duty. If they're not buying their first home - the usual stamp duty rules apply. If you bought the property as a first home buyer, opted



for the property tax and then turned it into an investment the scheme changes. You will be required to pay \$1500 plus 1.1 per cent a year. The policy is specifically designed to help first home buyers get into the property market.

When it comes to deciding whether to opt for the lump sum payment or property tax, you should take in to account your own personal situation. The median time people hang onto their homes in NSW is ten-and-a -half years. First home buyers generally keep them for a little longer than that. Everyone's circumstances are different and you should always get independent financial advice.

Whilst it is hoped the new legislation and changes will encourage more first home buyers to the property market, and at a faster rate, there are a few criticisms of the scheme including that there is a chance the price of houses will increase and there is the chance that future governments will increase the land tax rates. Labor has promised to repeal the legislation if they

win the March 2023 election.

It is important to note that the existing first home buyer stamp duty exemptions and concessions are not changing. The current exemptions and concessions for first home buyers include:

> than \$650,000, full exemption no stamp duty. Homes valued at between \$650,000 and \$800,000, concessional stamp duty rate.

Homes valued at less

Vacant land valued at less than \$350,000, full exemption. Vacant land valued at between \$350,000 and \$450,000, concessional stamp

The new scheme will be applicable to purchases of properties where the value is greater than the thresholds for the current exemption and concessions listed above, that is over \$800,000 for homes and \$450,000 for vacant land.

Australia's population is about to soar, but where are millions of extra people going to live?

Australia is expected to have a population of 29 million by the end of 2030, which is three million more than now, and keeping up with the growing demand for housing is going to be a major hurdle. The country's population went backwards during the

early stages of Covid, with a net loss of 85,000 people in the 2021 financial year.

But with borders reopened, Treasury expects net overseas migration will return to pre-pandemic levels this year, and remain at the long-run average of 235,000 people over the medium term. Unsurprisingly, the most

populous states of New South Wales, Victoria and Queensland are predicted to have the highest number of residents by June 2026.

NSW and Victoria are tipped to growing by 300,000 and Queensland by 400,000 to have resident bases of 8.5 million, 7 million, and 5.6 million respectively. "Ensuring the supply of new homes keeps up with Australia's growing population is going to be a key challenge over the coming years," PropTrack economist Anne Flaherty said.

Pete Wargent, co-founder of national buyer's agency BuyersBuyers, said that while population growth had temporarily halted due to Covid, it's been slowly creeping back up, adding pressure to the housing market.

"After a lengthy period of closed international borders, population growth hasn't been much in the news of late," Mr Wargent said.

"Now, for the first time in a decade, we have full employment and a genuine skills shortage, and after a hiatus, we should expect a strong rebound in net overseas migration."

Renters will be the first to feel the squeeze With Australia's border now open and universities welcoming back students from overseas, the competition for inner-city rentals is at an all-time high, driving prices up accordingly.

PropTrack's latest Rental Report for the September quarter shows rent prices have increased at the fastest quarterly rate on record, surging by 4.3% in the past three months to reach a national median of \$480 per week.

As the population increases rapidly in coming years, Ms Flahertly said many renters will be struggle to stay housed.

"There is already an undersupply of rental accommodation. A slowdown in development activity as population growth resumes will exacerbate supply issues over the coming years.

"This will reveal itself in the rental market – new Australians are more likely to rent than buy in their first few years, so this is where the pressure of a larger population will be first felt.

"If demand to rent outpaces the supply of new rental properties, this will drive rents further upwards."

Supply needs to keep up with demand

With more people in need of a roof over their head, encouraging investors to enter the market is a key consideration for governments.

Currently, soaring interest rates are leaving investors feeling unmotivated. New lending to landlords in August was \$8.9 billion, which is the lowest it's been since June 2021.

While the recent federal budget identified the issue and mapped out ways to tackle it, Ms Flahertly said authorities aren't acting fast enough.

"It was pleasing to see the Commonwealth acknowledge the importance of bringing together different tiers of government as well as private and institutional investors to tackle the supply issue as part of their Housing Accord. But their target of one million new homes is

from 2024 onwards."
Mr Wargent said to ensure more stock is being added to the market, borrowing needs to become more accessible to investors.

"At some point, it must become easier for landlords to borrow to supply the new rental stock that's needed," he said. Since October 2021, the

Australian Prudential Regulation Authority – the banking regulator – has required lenders to apply a 300 basis point serviceability buffer to home loan applications, to ensure borrowers would still be able to meet their repayments if interest rates rose by 3%. Previously, the buffer was 250 basis points. "Lending assessment buffers are too stringent at the

moment at 300 basis points, so it's no surprise that rental vacancy rates are at all-time lows and tightening," Mr Wargent said.

Building more is key for affordability

As of 2020, Australia had an estimated

10,558,000 residential dwellings, according to the Australian Bureau of Statistics.

While the number of dwellings developed each year fluctuates with market trends, the overall number produced has increased over the past 20 years from 146,500 dwellings per year to more than 201,000. But construction sector woes like supply chain disruptions, rising costs and a labour shortage, will put downward pressure on this figure.

Build-to-rent projects such as Home Apartments are creating more stock within the rental market, but aren't being built fast enough to keep up with the increase in population.

Government has stepped in to create more social and affordable housing through the Housing Australia Future

Fund, which will see 30,000 homes built in the first five years, but many say it's a drop in the ocean compared to what's actually needed.

It may sound like a substantial number of homes are being constructed, but Ms Flahertly said the pace of building had slowed due to several factors.

"While nearly one million new homes were constructed over the past five years, this is well out of the ordinary and was driven by extremely low borrowing costs and government supports such as HomeBuilder," she explained.



World Diabetes Day

Sunday November 13 was World Diabetes Day, and the Lions Club of Branxton set out to raise awareness of the prevalence of diabetes and the need to ensure a good diet and healthy fitness practice. Recently, national newspapers

have reported there is a crisis in the Australian health system because of the rising tide of diabetes. Doctors are calling for a national action plan to cope with the growing crisis. Incidence of diabetes has almost tripled in the last 20 years and Diabetes Australia estimates that more than three million Australians will have the disease by 2050. A hardhitting report recently published spelled out the dire medical consequences of succumbing to this disease. Professor of metabolic health and Director of The Boden Institute at the University of Sydney Stephen Colagiuri said: "Diabetes is a serious condition and its seriousness is often underestimated and not appreciated. It's not doom and gloom in terms of what can be done about it. The national strategy is a very good guide, but the strategy needs to be implemented to make a difference."

Pool safety saves lives

Cessnock City Council has launched its annual Be Pool Safe campaign which will promote the importance of swimming lessons, backyard pool safety, and supervision this summer. The fearful fact that kids can drown without a sound will be echoed during the campaign, and that swimming lessons can make all the difference.

The 2022 Royal Life Saving National Drowning Report highlighted the temporary closure of swim schools during the COVID-19 pandemic would likely impact Australians for years to come. This is due to kids missing long periods of swimming and water safety education, and many not returning to their lessons.

The report also noted that 339 people drowned in Australian Waterways between 1 July 2021 and 30 June 2022, with an estimated additional 686 involved in non-fatal drowning incidents. This is a 15% increase

compared to

the previous year, and a 24% increase compared to the 10-year average.

Cessnock City Council Mayor said with summer fast approaching, it was more important than ever to get your kids into swimming lessons, and educate them about pool safety.

"The NSW Government's First Lap vouchers are still available, which provide families with a \$100 voucher towards swimming lessons for children aged 3-6 years," Mayor Suvaal said. "I have two young kids who love the water and I'll be looking to get them into lessons in the lead up to summer. I encourage other parents to do the same."

Cessnock City Council is also issuing free family passes to Kurri Kurri Aquatic and Fitness Centre, and Cessnock and Branxton pools to kids who complete the NSW Department of Education Intensive Learn to Swim program.

Singleton calls for urgent assistance as \$15 million road repairs bill continues to climb

With a roads repair bill estimated at \$15 million and climbing in the wake of multiple flood emergencies, Singleton Council has joined calls for urgent assistance from the Federal and State governments to address the issue now. In a Mayoral Minute to last night's Council meeting, Mayor of Singleton, Cr Sue Moore said the scale and cost of repairs was beyond the



of any local government authority and delaying works would create greater issues for the future. The issue has been included on the latest Singleton Infrastructure Agenda.

Council resolved to join with Local Government NSW and Country Mayors Association of NSW in declaring a Statewide Road Emergency based on an estimated \$2.5 billion in road damages and resulting collapse of the local and regional road network.

Council will write to the Prime Minister Anthony Albanese, Federal Opposition Leader Peter Dutton, NSW Premier Dominic Perrottet, NSW Opposition Leader and local members of Parliament to raise the issue.

Cr Moore said unprecedented circumstances required an unprecedented response and called for urgent government assistance to boost and fast track existing roads funding programs as well as provide new funding for plant machinery and skilled workers to expedite road repairs.

"With three floods in the past 12 months alone, the impact on road infrastructure across the Singleton local government area is significant. Council staff have made a preliminary estimated cost of \$15 million, but we expect this number to continue to grow," she said.

"As well as the impacts on our assets, we must also consider the consequences for the local economy given the local and regional road network is critically enabling infrastructure and vital for primary producers and other industries reliant on road transport for the distribution of goods to markets and

"It is therefore urgent that all levels of government work together to address this issue not only for our community now, but for the future."



Editorial note: I received a copy of Mad Honey in exchange for a review. All opinions are my own. Mad Honey by Jodi Picoult and Jennifer Finney Boylan is an impactful and timely story that will stay with you.

Jodi Picoult does not shy away from covering relevant and to some, controversial topics. She has this masterful way of presenting a story that seems pretty clear cut on paper and then about midway, there is a twist that changes everything. Mad Honey is the latest

example of this. The novel, co-written with Jennifer Finney Boylan, covers so much: identity, gender, abuse, love, toxic relationships and much more. It's not an easy read and many times, it's quite sad but it's also important and I think will open many eyes to the struggles that people deal with on a daily

The story is told from the perspectives of Olivia and Lily. Olivia is a beekeeper and a mother to a teenager son, Asher. She left behind an abusive marriage to start over in her hometown in New Hampshire.

Whereas Lily is a teenager girl who just moved to the area with her mother. She is also hoping for a fresh start from a painful past. Asher and Lily eventually start to date and fall in love and for once, everything seems at peace. Until one day, Lily is found dead and Asher is the number one suspect.

While Olivia believes that her son is innocent, she starts to recognize similar traits that his father holds as well. She begins to question everything she knows.

Jodi Picoult mainly wrote Olivia's perspective while Jennifer Finney Boylan wrote Lily's. The final work is rather seamless and cohesive and I thought their collaboration was quite strong. I was so engaged with both characters and their journey. I so wished for a better outcome for Lily as her story is so heartbreaking.

In many ways, Olivia and Lily are quite similar. They have suffered abuse and left toxic relationships. And they both love Asher. Olivia's story is told in present time while Lily's is told backwards. I'm not sure why they made that choice—perhaps it was to keep the twist hidden

longer. It didn't bother me but I know some readers had a problem with that. I hope readers approach this Boylan has written thirteen story with an open mind. I keep these spoiler free and I don't want to reveal the twist. I think some will probably see it coming and others may not. I've read reviews that explain key plot points and sometimes it's fine for the particular story but other times, you want to go into the novel fresh and not have that reveal in the back of your

mind. I believe the authors chose to present the story like that for a reason and I want to respect their process. That said, speaking in somewhat vague terms, I feel like this was eve opening story covering a segment of the population that is underrepresented in the media-unless, they're being vilified by politicians. This story, while of course fiction, does give a face and voice to the journey that many people go through.

Verdict

Mad Honey is an important and impactful read. It's very well done and will make you think. And those are always the ideal book club selections.

I see why Good Morning America chose this for their October pick. It will for sure get a lot of people talking.

However, there is a melancholy feel to it though and it's quite tragic. So something to keep in mind.



Heart ailment forces trainer De Montfort to retire By Ray Thomas



Trainer Mark De Montfort has been forced into retirement due to a heart

ailment De Montfort, a former leading Sydney jockey, has been diagnosed with an excessively slow heart-rate that can cause fainting spells, fatigue and other medical problems. Doctors ordered De Montfort, 63, to stop riding trackwork which prompted the trainer to make the decision to retire.

'I've always said when I can't ride I don't think I want to train," De Montfort

"Riding has always been a major part of my enjoyment training racehorses so when the doctors said I couldn't ride anymore, my hand was forced earlier than when I would have wanted. "I've been doing this (trackwork) for 49 years without a break so it's a big shock to the system." De Montfort, a naturallygifted sportsman who is also years, preparing more than Trainer Graeme Green had very good golfer and touch footy player, has always been extremely fit and active but began to notice he was feeling fatigued at

"In the last month or two I was tired all the time and felt like I was unfit which I couldn't understand," he said.

and get my breath back.

"Basically, I have an excessively slow heartrate, my blood doesn't pump through fast enough. I could have a pacemaker fitted but my doctors said I needed a lifestyle change." "I got to spend more time with mum for the last two months which was a blessing," De Montfort said. De Montfort had been scaling down his Warwick Farm training business in his horses transferred to other stables Symo's Girl was De Montfort's last winner,

For cyber criminals, ransomware is the popular weapon of choice

By Rob Di Pietro Of all the cyber threat vectors, ransomware attacks remain among the most persistent, presenting a serious threat to Australian organisations large and

Since the beginning of the Covid-19 pandemic, when the rate of ransomware attacks spiked, we've seen a constant and steady increase in their numbers the Australian Cyber Security Centre's (ACSC) most recent threat report indicates in the 2020-21 financial year, ransomware attacks increased by 15 per cent. Even more worrying is that this number is likely just a fraction of the real scope, given cybercrime so often goes unreported. Despite the increasing rate of ransomware attacks, however, lived experience indicates some organisations are failing to effectively mitigate the risk of attack, with some still unsure of what ransomware

release or sell stolen data Ransomware is deployed by cybercriminals – both state and non-state actors who search for IT system vulnerabilities. The use of cryptocurrencies can make transfers to ransomware criminals hard to trace. And because these criminals are often located in extraterritorial jurisdictions - notably some Eastern European nations - where they are able to act with virtual impunity, there is little legal or law enforcement recourse for ransomware crimes.

As the popularity of ransomware as a cyber weapon of choice by cybercriminals has increased, ransomware "business models" have evolved.

"Ransomware as a service" models have seen the commoditisation of cybercrime, with ransomware malware sold on the

dark web for the use of amateur cybercriminals. An analysis from the US conducted in 2020 found buying malware online was "incredibly easy", with advanced malware tools selling for as little as \$US50 (about \$75). Furthermore, it reported "almost all premium malware sellers provide buyers with in-depth tutorials and ideas about using their products for

technically unskilled buyers" Head of the ACSC, Abigail Bradshaw, recently noted that sophisticated ransomware syndicates are often geographically dispersed to help them avoid traditional law enforcement and prosecution. Highlighting the increasingly slick business model, Bradshaw said: "A ransomware syndicate might have a marketing arm based in one country, an access arm whose sole job is just to obtain access to vulnerable networks in another country, and its franchise operation operating from another country.

As previously noted, "hack and leak" is a tactic now commonplace among ransomware criminals, as it offers the opportunity for double extortion. And while remains uncertain how an organisation of any size can be struck, "big game fishing" targeting large organisations remains a lucrative form of attack. The most common way these criminals get into systems remains via phish-

ing exploits but password guessing, credential stuffing (the use of stolen credentials often

bought on the dark web) and the scanning of networks for vulnerabilities are also key methods of entry. Ransomware actors are increasingly targeting executives and employees via "grab and go" tactics, whereby they threaten to release potentially damaging or embarrassing stolen data, which in turn creates additional pressure to pay the ransom.

As ransomware attacks continue to become more sophisticated there are several trends that may evolve.

The first will see cybercriminals increasingly enter systems via the backend, cutting out the need for the initial exploit and potentially providing far greater access to and control over systems. The second is that we may see these criminals pivot away from the use of cryptocurrencies for payment. This will be due to increased regulation of cryptocurrency globally, which is currently occurring, as well as severe fluctuations in cryptocurrency exchanges, which can dramatically reduce the profitability of these transactions. And while it

While some of the most spectacular ransomware attacks have occurred offshore, Australia has not been immune. Over the

past 18 months, major logistics company Toll Holdings Ltd has been hit twice; Nine Entertainment was brought to its knees by an attack that saw the company struggle to televise news bulletins and produce newspapers; multiple health and aged care providers across the country have been hit; and global meat supplies were impacted after Australian and international operations of the world's largest meat producer JBS Foods were brought to a standstill. It is likely other organisations have also been hit but have kept it out of the public spotlight.



Have we learnt precisely nothing from the Ruby Princess debacle in 2020, which led to the deaths of 28 people and unleashed a COVID-19 wave that could have overwhelmed the Australian health system?

Sure, almost three years later most of us are vaxxed and boosted and an influx of COVID -19 cases can do less damage – but should a behemoth like the Majestic Princess be free to flush out more than 660 sick passengers into the

community with nothing more than a warning to stay off public transport? We are already experiencing

our fourth COVID-19 wave, according to Chief Medical Officer Dr Kerry Chant, with a tripling of cases in the 24 hours to Thursday. Will the Majestic Princess's unwanted ballast be a "drop in the ocean", given those surging case numbers? This seems a let-it-rip or, in this case,

let-it-ripple policy. The cheapest fare paid by the 3300 passengers on the Princess Pandemic was about \$150 per day, which partly explains why cruising is so popular. According to the investigative website Cruise Market Watch, this ship carried 88,800 passengers in 2021, earning \$US130 million-plus (\$194 million).

That money goes back to the US -based parent company, Carnival Corporation & plc, which consists of two separate companies registered in the tax haven of Panama and in the UK. This means that while Australia receives no tax revenue from Carnival, the country's taxpayers will cover the health costs of the latest debacle. Footage of passengers

disembarking showed many of them to be elderly, the group with the highest risk of death or disability from COVID-19. This problem is not going to disappear but will be an ongoing, costly issue for the Australian health system. But COVID-19 is not the only negative outcome associated with cruising. The industry is very polluting, and its greatest impact in Australia is on residents near berths. In this country, the industry is much less regulated than in the US or Europe.

In 2013, the cruise terminal was moved to White Bay in lieu of being built at Barangaroo. Inner-west residents started to wake up wheezing and breathless. Doctors in adjacent Rozelle and Balmain started to see dozens of adults and children reporting mysterious medical symptoms, ranging from excruciating headaches to respiratory issues. Resident Lisa-Marie Murphy told Alan Jones on his radio show in 2015 that she was "horrified" when she learnt what toxins were in the fumes. "One of my daughters gets a splitting headache virtually every day the ships are in, and she doesn't want to go to school," Murphy said. "These are chemicals you don't want anywhere near your kids."

The problem was eventually identified as the pollutants from the cruise ships' diesel exhaust, which is carcinogenic. After extensive lobbying, the community eventually succeeded in getting a NSW parliamentary inquiry into the problem in 2015. From that, they won a few concessions;

from January 1, 2020 cruise ships had to switch to fuel with 0.5 per cent sulphur (it's 0.1 per cent in the US and Europe) one hour after they entered an Australian port.

They also won from the government the promise that when docked, the ships would switch to less polluting shore power. The Port Authority of NSW announced earlier this month that two shore power berths would be available in the Bays Port Precinct (Glebe and White Bay) by the end of 2024, to run on renewable energy. This would reduce carbon emissions by 14,000 tonnes per year, the equivalent of taking 4000 cars off the road, it said, adding that it would also reduce noise by 10 decibels.

This means residents will continue to suffer the health effects of these ships until the end of 2024, that is, two years away. How is that fair? There's no doubt that cruising is a very popular segment of the travel market and consumers deserve to have access to a product that delivers so much pleasure and value for money. I also have faith that Carnival enforces the COVID-19 guest protocols stated on its website, that all guests must be fully vaccinated (including boosters) and also provide either a selfadministered negative RAT within 24 hours of boarding or a negative PCR within 48 hours. But it's hard to see how, during another COVID-19 wave, a foreign company is allowed to abrogate its responsibilities to the Australian taxpayer by simply releasing medically compromised passengers into our health system. Again.

Knife crime targeted in two-day police blitz across NSW

Police have charged more than 140 people and seized numerous firearms and around 50 knives during a two-day state-wide blitz on knife-related crime. Operation Foil III was conducted between Thursday 17 November and Saturday 19 November 2022 to target young people in possession of knives in public and other known violent offenders.

During the operation, 144 people were charged and police seized six firearms, 48 knives, and prohibited drugs and weapons.

Additionally, intelligence-led targeting of locations and people resulted in almost 1000 move-on orders and transport infringements being issued across the two days. Police also conducted around 800 bail compliance checks

Deputy Premier and Minister for Police Paul Toole said the NSW Government remained committed to taking all necessary steps to reduce knife-related

crime.
"Everyone deserves to feel safe on our streets — and those that threaten that will face the consequences," Mr Toole

said.

"Knife crime can change someone's life in an instant, whether it's causing injury or death to innocent people or

injury or death to innocent people, or for offenders, ending up before the courts.
"The officers involved in Operation

FOIL have done an incredible job engaging with the community and helping prevent knife-related crimes to keep us all safe. "Operations like this one make a real

difference to our community, and the NSW Government will continue to work closely with Police on the best ways to prevent knife and youth-related crime and violence."



South West Metropolitan Region Commander, Assistant Commissioner Stuart Smith, said the model behind Operation Foil has proven successful throughout the year due to its twopronged approach.

"We have well-resourced police using intel to identify people and areas of concern related to knife crime with a view to supress any further violence or related criminal activity," Assistant Commissioner Smith said.
"That's the overt, high-visibility side of things; bail enforcement, suspect targeting – meanwhile, Youth Command is engaging with young persons who have been deemed 'at risk' of committing violent crime.
"The use of knives, particularly by young males, is a serious concern for police, and further operations are

planned to reduce their use and

Commissioner Smith said.



Five common Australian garden pests and how to get rid of them

While there are lots of bugs works well. that can be beneficial for your garden, others can be super destructive. If you've ever had an aphid infestation then you'll know what I mean.

Fortunately, many garden pests can be controlled using simple, organic solutions.

Here are five common Australian garden pests and what you can do to rid your garden of them:

1. Aphids

There are more than 4,000 species of aphids and they vary in colour, with white, black, green, yellow, brown and even pink varieties existing. The two most widespread species in Australia are the cabbage aphid and cotton aphid. As simple as it may sound, a great way to efficiently reduce an aphid population is by crushing the insects with your fingers or removing the affected part of the plant. Washing affected areas with cold water also

2. Cabbage Moth

The cabbage moth is a common pest found in vegetable gardens. It lays eggs on the underside of leaves, eggs which spawn larvae that eat said leaves in abundance.

Wasps abound in the garden, and most play an important role in pest control dealing with all sorts of pests including caterpillars, spiders and even house and stable flies. Wasps often gather insects to feed their young, while others parasitise pests and lay eggs into the unsuspecting insect. Many wasps are small and rarely noticed. One you may find evidence of in the garden is the mud wasp, which builds clusters of mud cocoons on walls. These large wasps are not dangerous and are carrying out insect control. If you can tolerate the mud colonies, your garden will benefit. Paper wasps, which build carefully crafted tiered nests hung in trees or shrubs or attached to beams or under eaves, are less benign if disturbed however they too are carrying out pest control in the garden. Highly dangerous and already common across southern Australia are the European wasp, which resembles a large honeybee but is an introduced pest. This wasp feeds on nectar but also insects and is attracted to sweet drinks and

OUR FAVOURITE FRIENDLY **GARDEN VISITORS**

Here are some good bugs you may find in your garden. While the adults are often easy to see, you may need a hand lens (such as a magnifying glass) to see all the life stages of these beneficial insects.

The native blue-banded bee. 1. BEES

Bees are probably the most recognisable of all garden insects as they buzz about foraging in flowers harvesting pollen and nectar. Honeybees are excellent pollinators and are vital to have if you want to produce fruit. As well European honeybees, there are also a host of native bees ranging from tiny to big insects such as the blue-banded bee and the teddy bear bee. Some native bees can be kept in small garden hives. Bees can consume. Ladybirds and be distinguished from wasns and flies as most carry pollen on their legs and can be observed flying from flower to flowe Green lacewings are easily

identifiable.

2. GREEN LACEWINGS Green lacewings are frequent insect visitors and an absolute whiz at pest control. These good bugs will be seen in the garden as small, green insects with lacy wings befitting their name. This is the adult stage. Adults feed on nectar and lay eggs on the underside of leaves. The eggs are held on

long strands. Leave them to hatch, as the larvae do most of the pest control, feeding on aphids, mealy bugs, thrips, whitefly and more. At just 2-8mm in length, these baby lacewings are hard to see, but if spotted they'll have grey segmented bodies, six legs, small pincers and often carry the remains of their egg sac on their backs. Lacewings are used commercially to control insects in nurseries and horticultural crops Ladybirds are beloved in the garden for more than one
